ORGANIZATIONAL OVERVIEW

The Wisconsin Legislature on September 1, 1939, created the Motor Vehicle Department and its Inspection and Enforcement Division, which would grow and evolve into the State Patrol.

The State Patrol has approximately 489 sworn law enforcement officers and 168 non-sworn staff members, who are assigned statewide. The major State Patrol headquarters facilities are located in Madison, Tomah, Waukesha, Fond du Lac, Wausau, Eau Claire and Spooner. The State Patrol also operates its training academy at Fort McCoy and has officers stationed at the Wisconsin Department of Transportation's (WisDOT) State Traffic Operations Center (STOC) in Milwaukee. To accomplish its mission, the State Patrol provides an array of services, programs and initiatives including the following:

PREVENTION OF TRAFFIC CRASHES:

Since its inception, the Wisconsin State Patrol has been dedicated to improving highway safety and reducing traffic crashes through effective enforcement and education. These efforts save lives and prevent injuries.

SAFETY INSPECTIONS OF LARGE TRUCKS, BUSES, MOTOR COACHES AND AMBULANCES:

As sworn law enforcement officers, State Patrol inspectors examine safety equipment on commercial motor vehicles along with drivers' logbooks and records. They also annually inspect every school bus in Wisconsin. Compliance reviews of motor carrier companies help ensure that vehicles and drivers are adhering to safety regulations and help educate the companies about legal requirements. Using federal funding from the Motor Carrier Safety Assistance Program (MCSAP), inspectors frequently respond to crash scenes involving a commercial motor vehicle to determine if any safety violations may have contributed to the crash.

ENFORCEMENT OF COMMERCIAL MOTOR VEHICLES' WEIGHT AND SIZE LIMITS:

At 13 Safety and Weight Enforcement Facilities (SWEFS) around the state, inspectors weigh trucks to ensure they are operating within legal limits in order to protect roadway infrastructure. Inspectors also patrol highways and use portable scales in their vehicles for weight enforcement.

CRASH RECONSTRUCTIONS AND FORENSIC CRIME-SCENE MAPPING:

Members of the Technical Reconstruction Unit (TRU) are assisted by other troopers around the state who are trained in crash reconstruction. They use electronic surveying instruments, drawing and mathematical software applications, crash data retrieval systems and computerized simulation to determine precisely what happened during a crash and why. More than 70 percent of the approximately 400 crashes reconstructed each year by the TRU are at the request of local law enforcement agencies. In addition, the TRU provides forensic mapping of crime scenes including three-dimensional bullet trajectory diagrams that demonstrate complex scientific evidence to juries. Fire investigators also have requested TRU mapping of homes and buildings where arson is suspected. Because of their knowledge and experience, members of the TRU often provide expert testimony in court cases.

ORGANIZATIONAL OVERVIEW

INTERDICTION OF CRIMINAL ACTIVITY AND DRUG-SMUGGLING, INCLUDING THE USE OF K-9 TEAMS: During traffic stops, State Patrol officers use their training and experience to identify possible indicators of criminal activity, such as drug smuggling. In searches for illicit contraband, State Patrol K-9s and their handlers are adept in finding illegal drugs, drug paraphernalia and explosives. The State Patrol K-9 program is funded through the legal forfeiture of assets by those who commit drug-related crimes. The State Patrol also coordinates interdiction efforts as a member of the federal High Intensity Drug Trafficking Area (HIDTA) program based in Milwaukee. The State Patrol is the lead agency in Wisconsin for the federal Domestic Highway Enforcement initiative, which “promotes collaborative, intelligence-led, unbiased policing in coordinated and mutually supportive multi-jurisdictional law enforcement efforts on the nation’s highways.”

STATE PATROL ACADEMY: The academy, located at Fort McCoy, provides comprehensive law enforcement training for members of the State Patrol—from experienced officers to new recruits. Other local, state and federal agencies also train at the academy and use its facilities including the Emergency Vehicle Operators Course (EVOC).

AERIAL TRAFFIC ENFORCEMENT, SEARCH AND RESCUE, AND SURVEILLANCE: The Air Support Unit has sworn officers who are licensed pilots ready to fly missions throughout the state using aircraft based in Madison, Eau Claire and Green Bay. From their airborne vantage point, they can detect speeding, aggressive driving, tailgating, unsafe lane changes and other traffic violations. When requested, the ASU also assists in search and rescue missions for missing persons and surveillance for law enforcement agencies.

PROTECTION OF PUBLIC OFFICIALS AND DIGNITARIES: The Dignitary Protection Unit provides protective services to elected officials and other dignitaries. These services include advanced reconnaissance of sites that will be visited, safe and secure transportation to the sites, as well as protection throughout the visit to the site.

PUBLIC SAFETY, HOMELAND SECURITY, AND ASSISTANCE TO OTHER AGENCIES: With a focus on preparedness and planning, officers have the training and resources to respond statewide to a wide-range of emergencies such as tornadoes, floods, forest fires, hazardous materials spills and other disasters that threaten public safety. Using the Incident Command System, State Patrol officers can be readily integrated with other law enforcement agencies for traffic and crowd control at large public events.

TESTING AND APPROVAL OF EQUIPMENT FOR ENFORCEMENT OF DRUNKEN DRIVING LAWS: The Chemical Testing Section distributes, repairs and maintains breath alcohol testing equipment for law enforcement agencies throughout the state. The section also trains officers on the use of testing equipment and offers guidance to prosecuting attorneys about legal issues regarding testing procedures. The section is responsible for certifying various types of ignition interlock devices (IIDs).

ORGANIZATIONAL OVERVIEW, HIGHLIGHTS, ACHIEVEMENTS

STATEWIDE COMMUNICATIONS NETWORK FOR LAW ENFORCEMENT:

Communications professionals manage a voice and data network used by local, state and federal agencies as well as the State Patrol. With this statewide network, law enforcement dispatchers (LEDs) at State Patrol posts can help direct officers in the field for responses to crashes, incidents and emergencies. The officers use mobile data computers in their vehicles to access driver's license records, criminal histories, and other information needed for enforcement actions.

DISBURSEMENT OF FEDERAL FUNDING TO OTHER LAW ENFORCEMENT AGENCIES FOR TRAFFIC SAFETY ENFORCEMENT AND EDUCATION:

In partnership with the National Highway Traffic Safety Administration, the Bureau of Transportation Safety plans, coordinates and funds programs to improve the driving behavior and decision-making of roadway users. Programs are designed to improve safety among motor vehicle drivers, passengers, commercial motor vehicle operators, motorcyclists, bicyclists and pedestrians.

COMMERCIAL MOTOR VEHICLE SAFETY CAMPAIGNS PREVENT LARGE-TRUCK CRASHES:

To prevent traffic crashes involving large trucks, buses and other commercial motor vehicles, State Patrol inspectors participated in motor carrier safety campaigns sponsored by the Commercial Vehicle Safety Alliance and the Federal Motor Carrier Safety Administration.

The State Patrol intensified its enforcement and education efforts during the annual Roadcheck, Brake Safety Week, and Operation Safe Driver campaigns. For instance, during the 72-hour Roadcheck period in 2013, the State Patrol conducted more than 950 inspections and detected more than 4,000 safety violations. As a result, 224 vehicles and 63 drivers were declared out of service until the violations were corrected.

A combination of effective law enforcement and safety education has helped improve commercial motor vehicle safety in Wisconsin during the last 10 years. In 2012, large-truck crashes declined approximately 26 percent compared with 2003. Moreover, large-truck crash fatalities dropped from 102 in 2003 to 71 in 2012, which was a 30 percent reduction

STATE ENDS 2013 WITH LOWEST NUMBER OF TRAFFIC DEATHS IN NEARLY 70 YEARS:

Wisconsin ended 2013 with 527 traffic fatalities, which was the lowest annual total since 1944. State traffic deaths in 2013 also were down 74—approximately a 12 percent reduction—from 2012 when 601 people died and 44 fewer than the five-year average of 571 deaths.

Traffic fatalities went down in 2013 in every category, including motorcyclists and pedestrians as well as drivers and passengers. The single biggest reduction was the number of passengers killed in crashes. Passenger fatalities fell by 41, from 124 in 2012 to 83 in 2013. The decrease in passenger fatalities was due in part to an increase in safety belt use in Wisconsin to an all-time high of 82 percent.

NEW OFFICERS JOIN THE RANKS:

The State Patrol added new troopers and inspectors with the graduation of 32 cadets in the 58th Recruit Class in March 2012 after 23 weeks of intense training. Cadets in the 59th Recruit Class began their training in October 2013 and 30 of them graduated in March 2014.

THE BUREAU OF TRANSPORTATION SAFETY FUNDS OWI TASK FORCES AROUND THE STATE:

To combat drunken driving, the State Patrol and law enforcement agencies around the state teamed up for Operating While Intoxicated (OWI) task forces using federal funding administered by the State Patrol's Bureau of Transportation Safety. There were 11 multi-jurisdictional task forces operating in federal fiscal year 2013. The effectiveness of the OWI task forces combined with other enforcement and education efforts helped reduce fatalities and injuries from alcohol-related crashes.

SERVICES OF TECHNICAL RECONSTRUCTION UNIT ARE IN HIGH DEMAND:

The 15 members of the Technical Reconstruction Unit assisted by other troopers around the state who are trained in crash reconstruction are in high demand for their expertise and stand

ready to respond whenever and wherever needed. In 2013, the TRU responded for a variety of crash reconstructions and forensic mapping of crime scenes. The following are just a few instances when the TRU's efforts were critical components of an investigation:

Mark Bucki was convicted of first-degree intentional homicide for stabbing and strangling his wife in Lincoln County before dumping her body in a swamp in Taylor County. TRU troopers provided forensic mapping at Bucki's Lincoln County residence in April 2013. Troopers from the Northwest Region provided forensic mapping in Taylor County where the victim's body was found. The TRU also provided the court with scaled diagrams of the crime scenes and a trooper testified in the criminal proceeding.

Gabriel Campos of Marshfield was sentenced to 40 years in prison after pleading guilty to first-degree intentional homicide for the stabbing death of Masie McCullough in September 2012. TRU troopers provided the forensic mapping of the crime scene and created scale diagrams.

A total of 15 automobiles and SUVs along with one commercial motor vehicle crashed on US 45 in Menomonee Falls during adverse winter-weather conditions on Dec. 8, 2013. There was one fatality when a vehicle struck the rear of the semi-trailer, and several other people sustained moderate to serious injuries. TRU troopers reconstructed the crash.

HIGHLIGHTS, ACHIEVEMENTS AND SIGNIFICANT EVENTS

AIR SUPPORT UNIT CONDUCTS AERIAL ENFORCEMENT MISSIONS TO DETER SPEEDING AND OTHER VIOLATIONS:

In 2013, the Air Support Unit (ASU) conducted approximately 64 aerial enforcement missions. Using an aerial vantage point, pilots in the State Patrol's Air Support Unit can identify traffic violations as they occur over an extended distance and expanse of roadways.

In addition, pilots can detect traffic violations in areas that are difficult for enforcement by officers on the ground such as construction work zones, no passing zones, and roadways without adequate shoulders or median crossovers.

STATE PATROL PROVIDES SECURITY FOR NATIONAL GOVERNOR'S ASSOCIATION MEETING:

In August 2013, the National Governors Association's (NGA) summer meeting returned to Milwaukee, and the State Patrol was called upon again to lead the complex security effort.

The NGA, a nonpartisan organization founded in 1908, is the collective voice of the governors of the nation's 55 states, territories and commonwealths. The NGA's annual summer meeting attracts not only governors and their staffs but former presidents, federal and state cabinet secretaries, foreign diplomats, national media and policy experts of every stripe.

The State Patrol Security Team lead a two-year planning effort that culminated in a security apparatus encompassing more than 150 troopers and inspectors, State Capitol Police officers and Department of Natural Resources wardens. The security efforts also involved local, county and federal agencies and the National Guard.

Governor Scott Walker remarked after the event, "When I offered to host the National Governors Association (NGA) summer meeting in Milwaukee, I knew extensive collaboration and preparation would be required to plan a successful conference. The safety and security of those participating in the meeting was a top priority, and the Wisconsin State Patrol played an invaluable role in keeping NGA attendees safe. I am immensely grateful to them for their role in ensuring the success of the NGA summer meeting."

NEW EFFORTS TO KEEP CHILDREN SAFE:

During national Child Passenger Safety Week in September 2013, State Patrol posts delivered child safety seats to approximately 25 hospitals and clinics. The medical facilities then distributed the seats to eligible low-income expectant mothers and families. The 500 infant safety seats and 400 booster seats for statewide distribution were purchased with federal funding administered by the State Patrol's Bureau of Transportation Safety.

To help ensure that children in vehicles are secured in the right seat in the right way, the State Patrol's Zero In Wisconsin program developed and distributed an instructional video in 2012 titled "How to Properly Use Child Safety Seats in Wisconsin." DRIVE SOBER MOBILE APP INTRODUCED:

To help motorists prevent a drunken driving arrest—or even worse, a crash—the Bureau of Transportation Safety launched its “Drive Sober” app for smart phones in March 2013. Since its introduction, more than 50,000 people have downloaded it.

The Drive Sober app includes a blood alcohol estimator, a designated driver selector and a function to find a safe ride home that uses the phone’s GPS to provide contacts for nearby taxi, mass transit and designated-driver services. CHOOSE YOUR RIDE VEHICLE ATTRACTS

ATTENTION: The State Patrol’s “Choose Your Ride” vehicle, which is half cruiser and half taxi, always gets plenty of attention on the highway and at public events. The vehicle is a high-mileage cruiser that the State Patrol could no longer use for patrolling highways and was destined for auction. The State Patrol’s Bureau of Transportation Safety used \$1,700 in federal funding for the design and application of the vehicle markings. The distinctive vehicle hit the road in June 2013 and appeared at 35 events in the first six months it was on the road.

MOBILE ARCHITECTURE FOR COMMUNICATIONS HANDLING (MACH) DEPLOYED:

The State Patrol and the Wisconsin Department of Natural Resources jointly funded the licensing of MACH for use by public safety agencies within Wisconsin. MACH software can be used by officers in vehicles, law enforcement dispatchers in communications centers and supervisors in emergency operations center to communicate and display the locations of public safety vehicles as well as incident locations on a shared map.

As a comprehensive incident management tool, the benefits of MACH include enhanced safety for officers as well as timelier and better coordinated multi-agency responses to crashes and other emergencies. The State Patrol began pilot testing of MACH in 2010, and the full deployment was completed in January 2014. A rollout to additional Wisconsin public safety agencies will continue. HIGHLIGHTS, ACHIEVEMENTS AND SIGNIFICANT EVENTS

LONG-TIME MEMBERS OF STATE PATROL K-9 UNIT RETIRE AFTER YEARS OF EXEMPLARY SERVICE:

K-9 Charlie, who began service with the Wisconsin State Patrol in 2006, retired from law enforcement activities in August 2013 and subsequently passed away after a battle with cancer in May 2014. During his career, Charlie partnered with Inspector Brian Wiginton and most recently with Trooper Chris Lohman. While assigned by the State Patrol to the Milwaukee High Intensity Drug Trafficking Area (HIDTA), Charlie and Trooper Lohman assisted in numerous narcotics seizures. Charlie was instrumental in approximately 1,500 searches resulting in 387 drug-related seizures during the course of his career. The State Patrol granted Trooper Lohman's request that he take ownership of Charlie after the devoted K-9's days of service ended. Trooper Lohman cared for his partner until the cancer progressed to the point that Charlie needed to be put to sleep.

Wisconsin State Patrol K-9 "Ivy" of the North Central Region—Wausau Post retired in 2013 after being diagnosed with a degenerative joint disease. Her partner, Inspector Tye Howver, received permission from the State Patrol to become her owner upon her retirement. Ivy began her service with the State Patrol in 2006 and was instrumental in assisting Inspector Howver in making numerous narcotics seizures. During their partnership, the team conducted more than 1,800 searches resulting in 472 drug-related seizures. Inspector Howver and Ivy also were responsible for the seizure of \$549,262. Most notable was a cash seizure from a commercial motor vehicle of nearly \$450,000 in April 2010. The follow-up investigation resulted in numerous drug related arrests and seizures in Minnesota and California.

The exterior design for the State Patrol's 2013 Ford cruisers won the International Police Vehicle Design Contest in the Federal and State Agencies Category sponsored by "Law and Order" magazine.

The vehicle design captures the look of vintage State Patrol cruisers to commemorate the 75th anniversary of the agency in September 2014. The contest judges commented, "This is a simple, but very classic and old-school design. It strikes a fine balance of just enough but not too much."
