To All Interstate Motor Carriers, Freight Forwarders, Brokers and Leasing Companies:

Subject: 2017 UCR registration

If you do not register before January 1, 2017 you may be cited by law enforcement. Important Notice: If you operated in 2015 or 2016 and did not register for UCR, you must pay 2015, 2016 and 2017 UCR fees to avoid possible enforcement actions.

This letter is being sent to you because you or your company is listed with the Federal Motor Carrier Safety Administration (FMCSA) as being in interstate operation as a Motor Carrier, Broker or Freight Forwarder. If you operate a tractor, truck, or bus in interstate or international commerce you must register for Unified Carrier Registration (UCR) and pay the required fees.

Details and exceptions: a) Interstate motor private carriers of passengers only and entities operating solely intrastate, that is, only in Wisconsin, are not required to register for UCR. b) Companies operating solely as brokers, freight forwarders or leasing companies are also required to register and pay a fee of \$76. c) But companies providing motor carrier services in addition to broker, freight forwarder or leasing services are required to pay the fee level set at the motor carrier level as shown in the table below. d) Do not include any trailer counts. e) Do not include power units operated only intrastate. You must maintain a list of power units you exclude from UCR via form UCR1. This form is available at www.ucr.in.gov. f) If you operate only small vehicles (gross vehicle weight rating or gross weight rating of less than 10,001 lbs.), your fleet size for UCR purposes is zero and you should register and pay in the lowest fee category (\$76).

Fee Brackets for Motor Carriers are as follows:

Fleet Size		Fee Per Company
From	To	
0	2.....	\$ 76.00
3	5.....	227.00
6	20.....	452.00
21	100.....	1,576.00
101	1,000.....	7,511.00
1,001	or more	73,346.00

Example: A motor carrier operating 4 tractors and 9 straight trucks has a fleet of 13 commercial motor vehicles and would pay \$452.00

Pay your Wisconsin fees through the website maintained by the State of Indiana, www.ucr.in.gov; this site is also available from a smart phone. **You may make online payment using MasterCard, Visa or e-Check. You may print a numbered receipt.** There is free Internet access at most local libraries and there is also a computer available for motor carriers for this purpose at the Motor Carrier Services Section office at the Hill Farms office at 4802 Sheboygan Avenue, room 151 in Madison, WI. **Registration forms that are mailed in cannot be paid via credit card.** Checks should be made payable to "Registration Fee Trust."
