Things you should know

To qualify for Hobbyist plates, you must own or lease at least one other motor vehicle for regular transportation with current, valid registration in Wisconsin under the same name(s) as the Hobbyist vehicle. Complete section **C**. Hobbyist plates are non-expiring for as long as you own the Hobbyist vehicle. Vehicles with Hobbyist plates cannot be operated during the month of January unless a special temporary plate is purchased (form MV2750).

If you previously had a Hobbyist plate, and no longer own the vehicle, pay the same fee as when applying for a second or subsequent hobbyist registration. See Fee Schedule.

WisDOT assigns a hobbyist number to each vehicle hobbyist. That number, plus an alpha character, is issued to other hobbyist vehicles owned by the same person. Motorcycle plates may be given a different plate number due to the character limit count. **Hobbyist plates cannot be personized.** Hobbyist plates cannot be issued with a disabled parking designation. For second or subsequent plates, allow approximately 3–4 weeks for the manufacturing process after the Certificate of Registration has been issued. Truck-type vehicles with Hobbyist plates cannot haul more than 500 pounds. To determine the gross vehicle weight, use the weight of the vehicle, full tank of gas, driver, passengers, any load you plan to carry.

Homemade/Reconstructed Vehicle (Trans 131.03 (12))

Emission test inspections are required on most hobbyist qualifying vehicles 1996 and newer kept in counties of Kenosha, Milwaukee, Ozaukee, Racine, Sheboygan, Washington and Waukesha. Emission test inspection must be completed no more than 45 days from the date of Hobbyist Plate registration issuance or plate transfer, or within 45 days of the date of an ownership change registration issuance, unless the vehicle passed inspection within 180 days prior to change of ownership.

For homemade and reconstructed vehicles, you may choose your vehicle's engine as the year of manufacture date. If you are requesting a waiver for emissions testing based on the year of the engine, and you are unable to provide the engine year, you will receive a Letter of Directive for an State Patrol vehicle inspection.

How to apply

- · Complete and sign application
 - » Select appropriate options that apply
 - » Give complete description of vehicle in section A
 - » Give owner information in section B
 - » Give complete description of vehicle registered in Wisconsin used for regular transportation in section C
- Send your original title (not a photocopy). If the vehicle is not titled in your name, send a completed title application (MV1 or MV11), title signed by Seller and fees, including Hobbyist registration fees
- For reconstructed vehicles, include a copy of your bill of sale
- Using the Fee Schedule, determine Hobbyist registration fees. No credit is given from current registration. If you are transferring a Hobbyist plate, you must pay the fee shown in the "Transfer" column. Make check or money order payable to: Registration Fee Trust

- ► Must be at least 20 years old
- ► Recognizable as the original year and make
- ► Has been altered from the original version

☐ REPLICA VEHICLE (Other than Motorcycle)

- ▶ Must replicate a vehicle at least 20 years old
- ▶ Replicates of a vehicle originally made by a manufacturer
- ▶ Indicate year and make vehicle is a replica of in Section A

☐ RECONSTRUCTED VEHICLE OR MOTORCYCLE

- ▶ Must be constructed from a vehicle at least 20 years old
- Substantially altered and no longer recognizable as the original vehicle
- ▶ Application must include bills of sale for all major parts used in the construction of the vehicle
- May need an inspection by a Wisconsin State Patrol inspector DMV will send a Letter of Directive for an inspection

☐ HOMEMADE VEHICLE OR MOTORCYCLE

- ► Must be at least 20 years old
- ▶ Must have been constructed from new or used parts
- May not resemble a previously manufactured motor vehicle (except motorcycles)
- May need an inspection by a Wisconsin State Patrol inspector DMV will send a Letter of Directive for an inspection
