

Purpose

We are seeking your input on proposed improvements and detour for the WIS 97 over Black Creek Bridge Project.

Project information


We are proposing to replace the thin polymer overlay (existing is debonding and in poor condition) on the WIS 97 bridge for Black Creek in the village of Athens in Marathon County. Secondary work items are proposed to include replacement and upgrade of guardrail to meet current WisDOT design standards, replacement of deck expansion joints, stabilzation of slopes at bridge abutments and repair of concrete surfaces at piers.



Proposed traffic impacts

Construction is currently scheduled for 2026.

During construction, WIS 97 is proposed to be closed and traffic detoured. The proposed detour route is County A to WIS 13 to WIS 64.





Real estate

Permanent right of way acquisition and temporary limited easements are currently not anticipated.
