Public Involvement Meeting, Vernon Village Hall September 19, 2023, 5:00 p.m. to 7:00 p.m.

Welcome to the Public Involvement Meeting for the reconditioning of WIS 164 from Henneberry Avenue to Denoon Road in Waukesha County. Representatives from the Wisconsin Department of Transportation (WisDOT) project team are available to address your questions and concerns.

Meeting Purpose

The intent of the meeting is to be informative. We are here to discuss the proposed project with you, answer questions, and listen to your comments, concerns and/or suggestions. This meeting will be in an open house format from 5:00 p.m. to 7:00 p.m. Please review handouts and exhibits at your leisure.

Attached to the handout is a sheet for your written comments and input regarding the proposed project. Please mail any written comments about the project before September 29, 2023, or leave them in the comment box tonight. You can also email your comments to the contact listed below.

Project Purpose

The purpose of the project is to improve safety, address deteriorating pavement conditions, and address deteriorating culvert pipes.

Proposed Improvements

Safey improvements along this segment of WIS 164 include new wider 6-Inch pavement marking, new guardrail, new centerline and shoulder rumble strips and wider paved shoulders. Shoulder improvements will be included: paving of shoulder from existing 3-foot paved and 7-foot gravel to new 5-foot paved and 5-foot gravel.

Improvements also include new pavement, new aggregate base, new culverts across WIS164 and new culverts across sideroads. The limits of the pavement replacement along WIS 164 are from approximately 430 feet south of Henneberry Avenue to approximately 670 feet north of Denoon Road.


Real Estate Requirements

Real estate acquisition of temporary limited easements, which expire upon the completion of construction, are being acquired for blending in slopes around culvert pipes and guardrail replacements. No new permanent right of way will take place in this segment.

Construction Staging/Detour Routes

WIS 164 will be closed to through traffic from Henneberry Avenue to Denoon Road during construction. The proposed detour route will utilize IH 43, WIS 83 and WIS 36.

During construction, WIS 164 will remain open for access to properties between Henneberry Avenue to Denoon Road, and work will be staged with flagging. During culvert replacements, direct access may require rerouting around the work site from another direction.



Construction Schedule

The project is tentatively scheduled for construction bid letting as early as May 14, 2024, if funds are available. Then construction may start in summer of 2024. If early funds are not available, a fall 2024 bid letting will have construction work in 2025.
