Larson Beach Road to south of Terminal Drive/Voges Road (2024 construction*)

- Replace the existing concrete pavement on this 4-lane divided expressway
- Reconstruct the southbound bridge over Taylor Road
- Add an auxiliary lane to the outside lane northbound and southbound between the north ramps of the Siggelkow Road interchange and Terminal/Voges Road intersection
- Seeking input on the intersection control at the Siggelkow Road ramp terminals

■ Exchange Street to Larson Beach Road (2026 construction*)

- Reconstruct the existing 4-lane urban section with intersection improvements
- Replace and lengthen the Yahara River Bridge
- Improve pedestrian accommodations

- Provide a two-way, left-turn lane (TWLTL) between Yahara Drive and Burma Road
- Provide agreed-upon mitigation measures for impacts to Babcock Park

Exchange Street (2026 construction*)

• Seeking input on the intersection control at Exchange Street and Tower Road

County B/AB to Exchange Street (2026 construction*)

- Reconstruct the existing 2-lane rural section with intersection improvements
- Pave shoulders to accommodate bicycles

Roby Road to County B/AB (2026 construction*)

- Expand the existing 2-lane rural section between Roby Road and County B (east) to a 4-lane urban section
- Provide a 10-foot-wide sidewalk on both sides of US 51 between Roby Road and County B (east)
- Construct a roundabout at the County B (east) intersection
- Reconstruct the existing 2-lane rural section from County B (east) to County B /AB to add continuous median and intersection improvements at each side road
- Pave shoulders to accommodate bicycles
- Seeking input on the intersection control at the Rutland-Dunn Townline Road intersection

Harrison Street to Roby Road (2026 construction*)

- Reconstruct the existing 4-lane urban section between Harrison Street and Hoel Avenue
- Expand the existing 2-lane rural section between Jackson Street and Roby Road to a 4-lane urban section
- Provide a 10-foot-wide sidewalk on both sides of US 51 between Jackson Street and Roby Road

Fifth Street to Harrison Street (2027 construction*)

- Reconstruct the existing 2- and 4-lane urban sections
- Improve pedestrian accommodations
- Update pavement markings at the Fourth Street intersection to provide a dedicated northbound left-turn lane
- Provide parallel bike routes

Spring Road to Fifth Street (2025 construction*)

- Reconstruct the existing 2-lane urban section
- Improve pedestrian accommodations
- Provide a bicycle lane in both directions

I-39/90 to Spring Road (2026 construction*)

- Reconstruct the existing 2-lane rural section
- Pave shoulders to accommodate bicycles
- Add an eastbound passing lane between Washington Road and Tower Drive
