## Purpose of the meeting

The Wisconsin Department of Transportation (WisDOT) is developing plans for the proposed improvements on WIS 133 from Brewery Hollow Road to the north junction of County N in Grant County. The purpose of this handout is to provide information regarding the proposed project, describe the potential impacts it would have on the community, and offer an opportunity for public comment. There will be no in-person public meeting. We appreciate your input and encourage you to review the project information and provide comments.



## Project information

WisDOT is proposing this project to address the deteriorating pavement along WIS 133. Project improvements include the following:

- Replacing the existing asphalt pavement
- Upgrading the beam guard
- Replacing 11 cross drain culvert pipes
- Installing centerline and shoulder rumble strips
- Placing new pavement markings
- Completing restoration work

## Proposed traffic impacts

Asphalt paving operations, beam guard replacement, and culvert replacements will be constructed using lane closures and flagging. Short term delays of up to 15 minutes could occur. Access for residents, businesses and emergency responders in the project limits will be maintained during construction.

## Real estate

Real estate needs are in the process of being determined, but additional right of way may be required for this project. If found necessary, real estate purchases would be located at beam guard for slope improvements and culvert pipe replacements for drainage and riprap improvements. WisDOT expects to complete the real estate process in 2025-2026.
