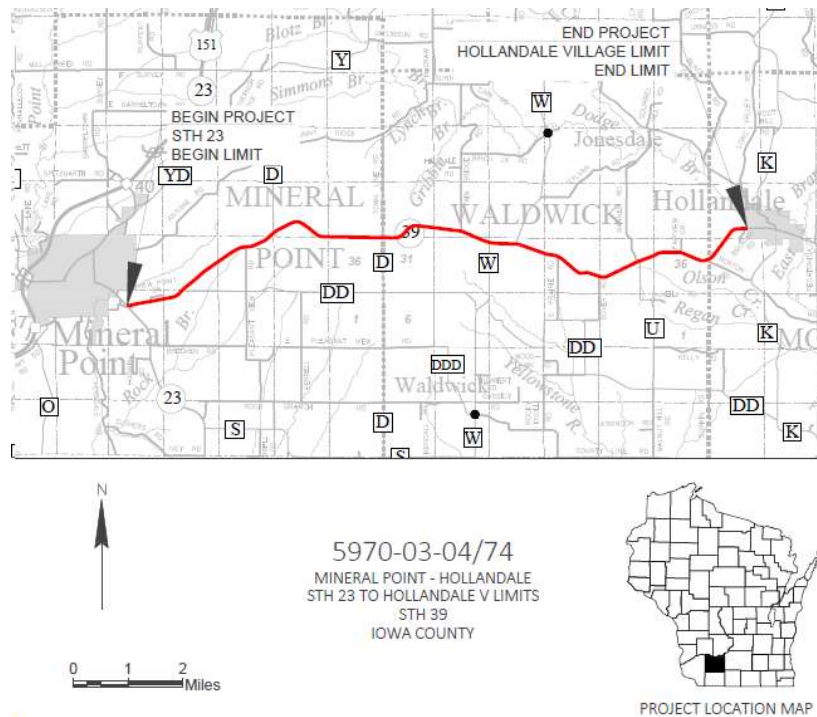

Purpose of the meeting

The Wisconsin Department of Transportation (WisDOT) is developing plans for the proposed improvements on WIS 39 from WIS 23 to the village of Hollandale in Iowa County. The purpose of this handout is to provide information regarding the proposed project, describe the potential impacts it would have on the community, and offer an opportunity for public comment. There will be no in-person public meeting. We appreciate your input and encourage you to review the project information and provide comments.



Project information

The purpose of the project is to address the deterioration of 12.5 miles of the existing WIS 39 roadway surface and improve safety to maintain a safe and efficient transportation system between WIS 23 and the village of Hollandale. See the above project location map. The following work is proposed on WIS 39:

- Milling/removing the existing asphalt pavement from WIS 23 to the village of Hollandale and placing new asphalt pavement.
- Applying a high friction surface treatment to WIS 39 on the reverse curve just east of the County D (south) intersection.
- Upgrading beam guard.
- Installing centerline rumble strips.
- Applying new pavement markings.

Proposed traffic impacts

Construction is currently scheduled for the summer of 2031 but could occur as early as 2027 depending on funding.

During construction, WIS 39 would remain open to local and through traffic using single lane closures and flagging operations. Motorists can expect some delays to occur during these operations. Access to residences and businesses will be maintained except for short periods while construction operations are directly adjacent to the driveways.
