
Project information

The Wisconsin Department of Transportation (WisDOT) is planning improvements on 1.36 miles of WIS 73 between WIS 19 (Main Street) and the north Marshall village limit, approximately 200 feet north of Converse Avenue, in Dane County.

The purpose of the project is to address the deteriorating pavement condition on WIS 73, improve safety and mobility, and extend the service life of the bridge over the Maunesha River.

Proposed improvements include:

- New road surface: remove the existing asphalt pavement and replace it with new pavement.
- Accessibility upgrades: upgrade curb ramps to meet the American Disabilities Act (ADA) standards for better accessibility.
- Bridge enhancements: installation of new concrete approach slabs, curb repair, spot surface repair on abutments, and painting the railing.
- Pavement markings: new pavement markings will be added for clear centerline guidance and bicycle accommodations.
- Railroad crossings: upgrading the railroad crossing signal equipment at Wisconsin and Southern Railroad crossing just north of Freidel Drive.

Proposed traffic impacts

Construction is currently scheduled to begin in 2025.

During construction WIS 73 will be closed to through traffic and a detour route will be in place. The roadway will remain open for local and business access. The proposed detour route would use WIS 19 and WIS 89 for both northbound and southbound traffic. Local and emergency access on WIS 73 would be maintained during construction.

Real estate

Additional right of way will be required for this project at curb ramp locations. The majority of right of way needs for the project will include temporary limited easements; however, there will be some spot locations that require minimal permanent right of way to maintain the curb ramps.

WisDOT began the real estate acquisition process in July 2023.
