### **WisDOT Bridge Inspector Refresher Training Requirements**

WisDOT has determined a minimum of 18 hours of bridge inspector refresher training completed during the grace period between June 6, 2019 and June 6, 2024 must come from the preapproved list below. Each inspector is required to keep a record with any supporting documentation of the courses taken, including the dates, the hours of qualifying refresher training, and upon request, supply the documentation to WisDOT. An individual tracking form is attached below which may be used to track your training progress. To remain a Wisconsin certified bridge inspector, complete at least 18 hours of refresher training and completed the WisDOT Inspection Refresher Training Record by June 6, 2024. If requested, the inspector is required to supply refresher training records to WisDOT for review.

### **WisDOT Bridge Inspector Refresher Training Requirements**

#### NOTE: Retaking the same course that has not been updated since the last time taken, does not count towards refresher training.

18 hours of refresher training is required for every 60-month period. This is a rolling schedule – the training hours are good for 60 months past the date the training was received. The same number of hours must be accounted for in new approved training before 60 months passed the date of the expiring training hours. For example, 5 hours of the WisDOT 2019 Structure Inspection Refresher Series taken in the fall of 2019 are removed from an inspector's qualification in the fall of 2023 (60 months after completion of the course), a minimum of 5 new hours must be added to the inspector's records by fall of 2023. After June 6, 2024, the only FHWA approved course is the 18-hour NHI 130053 Bridge Refresher Training Course.

A refresher training grace period, which ends June 6, 2024, was allowed for WisDOT approved training. The preapproved refresher training is provided on the BOS webpage. A minimum of 18 hours of training must be completed between June 6, 2019 and June 6, 2024. Hours of WisDOT approved training will carry over past the end of the grace period but only FHWA approved courses can be taken after June 6, 2024 to cover any courses that fall off, as explained in the above paragraph.

Inspector training records are required to be maintained by WisDOT in the future. Refresher training taken after June 6, 2024, WisDOT will request copies of the course completion certificates.
