

DIE-GEST TRAFFIC

A summary of traffic accident data you can use in your contacts with citizens. These facts and figures are from the National Safety Council monthly publication, TRAFFIC SAFETY.


M OTOR-VEHICLE deaths in June 1975 totaled 4,240, a decrease of 2 per cent from the June 1974 total of 4,330 and a decrease of 19 per cent from the pre-energycrisis June 1973 total of 5,250. The June 1974 total was the lowest since the June 1965 total of 4,111.

Deaths for the first six months of 1975 totaled 21,260, an increase of 3 per cent from the six-month total for 1974 of 20,610 and a decrease of 20 per cent from the corresponding six-month period in 1973. Deaths for the 12-month period ending June 1975 totaled 46,850.

Disabling injuries for the first six months are estimated at about 800,000. These are injuries resulting in disability beyond the day of the accident, and do not include minor injuries which probably totaled as many more.

The cost of motor-vehicle accidents for the first six months of this year is estimated at slightly more than \$7.5 billion.

Based on preliminary vehicle mileage reports for this year, the estimated mileage death rate for the entire year would be 3.6 (deaths per 100 million vehicle miles), no change from the 1974 rate of 3.6.


FLEET ACCIDENTS THEN AND NOW

As the Smokey Badger goes to press, this is the picture for 1975 fleet accidents as compared to 1974. Solid black indicates a day with more than one fleet accident.

ACCIDENT OF THE MONTH

THE ACCIDENT

Driver stated that he was driving southbound on a dirt road, moving about 40 mph; the time was 12:30 a.m., and it was raining. While going into a curve, he found the road slippery and took his foot off the accelerator. As he rounded the curve, he saw a vehicle standing across the road; the stalled vehicle was without lights. The driver tried to brake, but his wheels just locked and skidded, so he tried to go around the left side of the stalled car. He started to skid sideways and since there wasn't any clearance, he headed for the lefthand ditch, but the right side of his vehicle struck the stalled car. He finally went into the ditch doing about 30 mph, damaging the left front fender, hood, bumper, and grill of the other vehicle.

DISCUSSION

The Accident Review Committee classed the accident as PREVENTABLE, for these reasons:

- He knew the condition of the road (wet and muddy) and should have known that it would be slippery.
- His speed was too fast for weather conditions and the arc of the curve.


Radio Communications By The Barry

Gov. George Busbee of Georgia announced recently that \$96,000 from the State Emergency Fund would be used to equip 460 State Patrol cars with CB radios. Also, six

State Patrol base stations were to be outfitted with CB radio.

Oklahoma State Troopers are now issuing citations to motorists for the good things they do instead of the bad. A driver identified by a trooper for showing rare judgement and driving skill in avoiding accidents may be stopped and issued an Exemplary Driving Citation. Each trooper may issue only five such citations in each year.

Under a new law in the State of Washington, drivers may now purchase and install on their vehicles a colored light system which signals what action the driver is taking. A green light shows when the car is accelerating, an amber light comes on when the vehicle is slowing or decelerating and a red light appears to show when the driver is stepping on the brake. This became legal on September 1, 1975. The system, which will cost the average car owner about \$65.00, is intended to help avert rear-end collisions.

The first of a series of an \$80 million network of 84 state-owned inspection stations to test motor vehicle emission controls is planned. As now envisioned, the new emissions inspections program will utimately require 6.6 million auto owners to have their vehicles checked and, if necessary, spend up to \$150 on repairs before they will be issued new license tags each year. The last time that the state attempted an anti-smog program, it turned into an environmental and political whirlpool of controversy. That's in California.
