Application Denials

No Limit Auto Sales LLC. MV5599. The dealer's license renewal was denied after the department determined No Limit Auto Sales LLC forged a certificate of title and statement of intent for a vehicle, and engaged in providing false statements on title applications.

Vincent Awosika. Buyer's license. New World Motors LLC. The license was denied after the department determined the applicant previously sold vehicles without a license, and committed additional violations when operating under an prior dealer license.

Citations

One Way Auto Exchange LLC. MV5444. 1 citation for missing work – failure to submit title application within 1 business day.

Beeyond Engineering LLC. MV4284. 5 citations totaling \$1,017.50 for missing work – failure to submit title applications within 1 business day.

Teco Automotive. MV5472. 2 citations totaling \$407.00 for missing work – failure to submit title applications within 1 business day.

Hopkins St Auto Sales LLC. MV5418. 6 citations totaling \$4,626.00 for unlicensed retail sales.

Suspensions

Sorenson Motors. MV3705. The dealer served a 5-day suspension for multiple violations including: failing to make records available to the department; failing to maintain business hours; conducting a sale on a Sunday; and employing a unlicensed salesperson.

Car Planet Inc. MV5091. The dealer served a 3-day suspension for multiple violations including: failure to process title and registration applications within 7 business days; not accurately completing used vehicle general condition disclosures; failing to maintain required records at the licensed business facility; and entering into a retail installment contract with a retail customer without completing the proper paperwork.

Revocations

Keosyn Des Voitures LLC. MV5133. The dealer falsely reassigned vehicles from multiple wholesale dealers to Keosyn Des Voitures LLC, falsified title and registration documents identifying Keosyn Des Voitures LLC as the selling dealer, and knowingly gave false statements on title applications.

Car Rangers LLC. WHL8756. The dealer sold vehicles to retail customers without a retail dealer license. Car Rangers LLC purchased vehicles with high mileage, rolled back the odometers, altered titles to reflect lower mileage, and provided false odometer statements to customers.

Vince Auto Group LLC. WHL901. The dealer sold vehicles to retail customers without a retail dealer license.

Arlington wholesale dealers. During the month of August, the department revoked the wholesale dealer licenses from 129 dealers previously located at 101 Skyline Drive #1 in Arlington, WI. The dealers violated state law when they failed to maintain business facilities as required by Wis. Admin. Code ch. Trans 138.03(1) and Trans 138.04(3).
