# **Auction block ticket disclosures**

A block ticket accompanies any vehicle sold through Wisconsin motor vehicle auctions and it includes certain disclosures regarding the general condition of the vehicle. The auction block ticket must include the following information:

- 1. That the vehicle is used.
- All material history. "Material" is any information which a reasonable person would attach importance to, or information a seller knows or has reason to know the buyer would find important. The seller knows the information is important if the buyer specifically requests the information.

- 3. Prior use of the vehicle.
- 4. Title brands.
- 5. Prior jurisdictions where the vehicle was titled. If the vehicle has only been titled in Wisconsin, the disclosure must state Wisconsin.

Some block tickets from out-of-state motor vehicle auctions may not conform to Wisconsin standards. If the block ticket does not include the required disclosures above, you must complete a separate MV2895 Wisconsin Wholesale Buyer's Guide and include these disclosures.

#### Milwaukee city and county tax increases



On January 1, 2024, the city of Milwaukee and Milwaukee County would see an increase to sales taxes, according to an August 31, 2023 announcement from the Wisconsin Department of Revenue (DOR).

The city of the Milwaukee will increase its sales tax by 2%. Milwaukee County will increase its sales tax by 0.4%. Dealers should be aware of these increases in sales tax when transacting sales to Milwaukee County or city of Milwaukee residents.



## Licensing of internet sales staff required

Staff working a dealership's Business Development Center (BDC) or internet sales departments must be licensed salespersons if those staff are discussing vehicle pricing, vehicle options, or otherwise making an offer to sell any vehicle to a potential purchaser.

A "salesperson" is anyone who is in involved in the selling or leasing of motor vehicles.

<u>The definition of "sell"</u> includes not only negotiating vehicle sales, but also displaying, depicting, or describing vehicles to potential purchasers and indicating by any means that the person is willing to sell the vehicle to the potential purchaser; and accepting or negotiating an order to purchaser a vehicle by fax, telephone, or the Internet, if the vehicle purchased is delivered to the purchaser within Wisconsin.



## Heavy truck plate renewal fee reminder



When mailing manual application(s) to WisDOT for heavy truck plates (10,000 lbs and over) with issuance in the last quarter of a calendar year (October-December), remember to include the prorated plate fee for the current calendar year and the next calendar year's full registration renewal fee. Some customers may not receive a registration renewal notice mailed for heavy truck plates that are issued in the last quarter of a calendar year. Not including the necessary calendar year's registration renewal fees for all desired calendar years can cause a delay in plate renewal.

### Field Investigation Unit (FIU)

The following statistics represent the Field Investigation Unit's compliance efforts, community outreach and enforcement actions.

#### APU/DLU

The Agent Partnership Unit (APU) answers phone calls from dealers, government agencies, financial institutions, gas stations, grocery stores and various other types of agents throughout the state. These agents electronically process either title and registration, or renewal registration applications on behalf of the DMV.

The Dealer Licensing Unit (DLU) issues and renews multiple business license types. Individual licenses are issued to individuals who are selling or purchasing vehicles on behalf of dealerships. DLU answers dealer licensing questions as well as provides information about consumer harm and how to file a dealer complaint to the general public.
