EMERGENCY VEHICLE WEIGHT POSTED BRIDGES ON WISCONSIN INTERSTATE HIGHWAYS AND WITHIN ONE MILE OF INTERSTATE INTERCHANGES

Emergency Vehicle (EV) Weight Limits:

Single Axle: Allowable weight on any individual axle. If two axles are less than 40 inches apart, they are to be considered a single axle with their combined weight subject to the single axle weight limit. Tandem: Allowable total weight on two or more consecutive axles over 40 inches apart but not over 96 inches apart. If there are 3 axles within that distance, they are also to be considered a tandem. Gross: The total allowable weight of the vehicle.

Additional Notes:

EV weight limit signs only apply to emergency vehicles, most commonly firetrucks, that may exceed standard highway weight limits without a permit according to Section 1410 of the FAST Act (P.L. 114-94) and Wisconsin Statute 348.18. Operators driving non-emergency vehicles should continue to follow standard weight limit regulation and signage, obtaining permits when necessary (refer to Wisconsin Statutes Ch. 348).

EV operators should also follow standard gross weight limit signs in place for other vehicles. For example, if the bridge is already posted with a standard 30-ton gross weight limit for all vehicles, a new EV-specific weight limit sign will not be placed. Firetrucks exceeding 30 tons should avoid this bridge as well. A list of bridges on Wisconsin state system higways is available at the link below. For locations local system bridges with weight limit postings, EV operators should contact roadway authorities in their service areas.
