

# **FIRST OFFENSE OWI**

## **DON'T TAKE THE CHANCE.....**



### **PENALTIES/COSTS INCLUDE:**

<b>Penalties</b>	<b>Cost</b>
Fine/Forfeiture	\$150-300 (Plus \$485 OWI surcharges)
License Revocation: 6-9 Months	\$200 Reinstatement Fee
Occupational License: Eligible Immediately	\$50
Ignition Interlock Device Restriction: 12 Months (If AC is 0.15 or more)	\$65-\$70 Per Month Plus installation and Removal Fee
Intoxicated Driver Program Assessment	\$150-\$370/Varies by County/Tribal Agency
Driver Safety Plan Referral from Assessment	\$251 (minimum, <b>if</b> education referral)
SR 22 Insurance Filing Required During Timeframe of Holding Occupational License	Rates Vary by Insurance Company and Driver Record

# **SECOND OFFENSE OWI (WITHIN 10 YEARS)... DON'T LET IT HAPPEN TO YOU!**



## **PENALTIES/COSTS INCLUDE:**

Fine/Forfeiture	\$350-\$1,100 (Plus \$485 OWI surcharges)
License Revocation: 12-18 Months + Confinement Length	\$200 Reinstatement Fee
Occupational License: Wait time 45 Days	\$50
Ignition Interlock Device Restriction: 12-18 Months	\$65-\$70 Per Month Plus installation and Removal Fee
Intoxicated Driver Program Assessment	\$150-\$370/Varies by County/Tribal Agency
Driver Safety Plan Referral from Assessment	\$362 (minimum, <b>if</b> education referral)
Jail Time: 5 Days to 6 Months	Daily Costs
Possible Probation	Monthly Fees
SR 22 Insurance Filing/3 Years from Reinstatement Eligibility	Rates Vary by Insurance Company and Driver Record

# **THIRD OFFENSE OWI ...**

Fine/Forfeiture	\$600-\$2000 (Plus \$485 OWI surcharges)
License Revocation: 2-3 Years + Confinement Length	\$200 Reinstatement Fee
Occupational License: Wait time 45 Days	\$50
Ignition Interlock Device Restriction: 2-3 Years	\$65-\$70 Per Month Plus installation and Removal Fee
Intoxicated Driver Program Assessment	\$150-\$370/Varies by County/Tribal Agency
Driver Safety Plan Referral from Assessment	\$362 (minimum, <u>if</u> education referral)
Jail Time: 45 Days to 1 Year	Daily Costs
Possible Probation	Monthly Fees
SR 22 Insurance Filing/3 Years from Reinstatement Eligibility	Rates Vary by Insurance Company and Driver Record

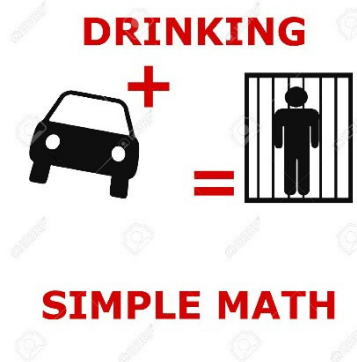

**Class "H" FELONY!**

<b>Penalties</b>	<b>Cost</b>
Fine/Forfeiture	\$600-\$10,000 (Plus \$485 OWI surcharges)
License Revocation: Lifetime (LR)	\$200 Reinstatement Fee
Occupational License: None	N/A
Ignition Interlock Device Restriction: 2-3 Years	\$65-\$70 Per Month Plus installation and Removal Fee
Intoxicated Driver Program Assessment	\$150-\$370/Varies by County/Tribal Agency
Driver Safety Plan Referral From Assessment	\$362 (minimum <b>if</b> education referral)
Jail Time: 60 Days to 6 Years	Daily Costs
Possible Probation	Monthly Fees
SR 22 Insurance Filing/3 Years from Reinstatement Eligibility	Rates Vary by Insurance Company and Driver Record
