# 31st Annual DBE Workshop and Secretary's Golden Shovel Award


PURSUE • WIN • EXECUTE: Diversifying Contracts in Design and Construction

was the theme for the 31st Annual DBE Workshop and Secretary's Golden Shovel Award conference where more than 100 contractors, consultants, government and community stakeholders were in attendance. For 31 years WisDOT has been instrumental in ensuring minority, female, small contracting and consultant firms participate on highway projects through the Disadvantaged Business Enterprise (DBE) program.

Since 2016 the National Association of Minority Contractors-Wisconsin Chapter (NAMC-WI) volunteered as the sponsor for the Annual DBE Workshop Conference and has led the charge in expanding the DBE Program network by

Findorff & Son, Kiewit, and MP/Pieper Power participated in our 1-on-1 networking with DBE contractors and consultants. Contracting officials from the cities of Milwaukee and Madison were also in attendance. Michele Carter, DBE Program Chief, stated, "Wisconsin's construction contracting

Funding and opportunity has shifted from federallyfunded road construction projects to publicprivate funding partnerships that construct major building and community developments."

Members of NAMC-WI used this opportunity to recognize Golden Champions of Leadership in Minority Business Development in Wisconsin

Construction Industry. One of the five recognized Golden Champions in the Construction Industry, United States Congresswoman Gwendolyn Moore, commented, "The Golden Shovel Award Conference demonstrates the Wisconsin Department of Transportation's longstanding commitment to significant inclusion of businesses owned by people of color, women and veterans on its construction projects. WisDOT, which has garnered national recognition and requests for technical assistance from other states that want to model its success, should be proud of its leadership in this arena. The inclusion of DBE businesses is not just a nice thing to do, it has real economic consequences. Many of the DBE firms hire a diverse workforce and create familysupporting jobs for economically challenged segments of our population. Individuals employed in construction and related service industries pay taxes and have money to spend on food, clothing, shelter, and discretionary items. In a nation where 71% of the economy is based on consumer spending, discretionary spending is important." She also applauds NAMC-WI for their sponsorship of the conference, and on-going commitment to expand contracting opportunities while increasing the number and capacity of minority contractors.



31st ANNUAL DBE WORKSHOP AND SECRETARY'S GOLDEN SHOVEL AWARD CONTINUED

DBE participant total of 94 representatives from 54 DBE firms. Multiple firms brought more than one staff person to ensure maximum participation in all workshops and sessions at the conference. Total attendance reached 252, exceeding a 10-year high, with external stakeholders numbering 205 and 47 WisDOT volunteers in full force.

Notably, the support of 50 highway and building trades contractors and consultants, some of whom volunteered their expertise to network with DBE firms and participate in our Project Detail Discussions (PDD), was a significant factor in this year's success. The Project Detail Discussions (PDD), a new feature this year, allowed DBE firms to meet with project engineers and subject matter experts and receive immediate feedback to long awaited questions. Valuable topics covered during these 30 minute sessions included business development and assessment, bid submission details, job scheduling, projects suitable for small businesses, quantity estimates and qualification, capacity prerequisites, and critical path requirements. Participation in the PDDs included government agency representatives from the City of Milwaukee, the Housing Authority, the City of

Madison, and Milwaukee County Community Business Development Partners. Project experts addressed questions pertaining to the Couture high rise, Milwaukee Bucks Entertainment Block, the Milwaukee Streetcar, Milwaukee City Hall Deep Foundation and Restoration Project, and the BMO Harris Bank Downtown Building Project. WisDOT project managers were also available to address questions pertaining to the 2017 construction lets, I-39/90 Expansion Project, WisDOT Local Program, prevailing wage guidelines, and the Consultant Financial Report. 





Acutely aware that employees thrive on a good company culture, Cheryl sets asides her time to get to really know her employees and what motivates them. For her, "it's all about developing your people in whatever role they aspire to be and helping them succeed at that role."

Today, ISC is just shy of \$15 million in sales, and does business across the country at the state, municipal, and federal contracting levels. ISC currently employs 70 people.
