Questions may be answered in any order, but please clearly indicate in the presentation which question is being answered:

- 1) Construction Inspection for Freeway Reconstruction Projects - What are your team’s qualifications with interstate work, capacity to deliver over the duration of the project and strategies for success on this project?
2) The IH-94 East-West Corridor will be delivered by an integrated team of consultant and Department resources. Please share with us your approach to the working relationship between key staff. What processes will you employ to ensure the integrated delivery team is successful?
3) Public Involvement and Stakeholders: Coordination and Outreach during Construction - What are your team’s qualifications, availability and capacity to deliver over the project term, and strategies for success on this project?
4) Please share with us your Team’s experience addressing safety issues on past projects and describe for us what your Team will do to address the safety needs of this project. Provide a specific example with a contractor and describe how the issue was addressed.
5) Conflict Resolution – Please describe your approach in working through issues with contractors. Explain your processes for timely issue resolution within the provisions of the contract.
