Bayfield County Planning Study	Bayfield County	\$59,200
Funding for this project will allow for the development of a Countywide Bicycle and Pedestrian Plan. The Plan will serve as a guide for the further development of bicycle and pedestrian facilities and as a strategy to enhance opportunities for bicycling and walking in Bayfield County.		
City of Prescott Planning Study	City of Prescott	\$194,106
The study will explore the addition of a trail and safe crossings for bicyclists and pedestrians along USH 10 and STHs 29 and 35, in order to facilitate non-motorized access to local schools and businesses. It will consider multiple trail locations and crossing types, including underpass, overpass, and at-grade. The finished plan will include preliminary design work for recommended infrastructure, environmental reports, and cost estimates, allowing the community to transition directly into construction.		
Stanley Community Trail Phase 2	City of Stanley	\$682,400
The City of Stanley is requesting funding to complete phase 2 of the Stanley Community Trail. This phase consists of a limestone trail on the School District's property, bike lanes that connect the school, the central business district, the parks, and an additional section of limestone trail to create a bike trail loop. This community trail will provide direct bicycle access across the entire City of Stanley, from the school to Chapman Park.		
Walking Iron Trail	Dane County	\$1,000,000
Funding for this project will construct 3-miles of multi-use trail on the former rail bed between the future Wisconsin River Recreation Bridge and trailhead parking lot off WIS 78.		
Frederic School District	Frederic School District	\$817,514
The project includes the installation of a pedestrian-bicycle path that will connect the District's elementary and Grade 6-12 schools. The project will result in a safe path, including directional signage, lighting, enhanced bike storage structures at each school, and any necessary curb work. The path is part of the SRTS plan.		
North Central Wisconsin Regional Safe Routes to School Program (Rural)	North Central Wisconsin Regional Planning Commission	\$49,600
This SRTS study is projected to address two rural school districts, and seven total schools. This will include case studies and profiles on successful projects and activities as models for other districts to follow to advance their own SRTS efforts.		
Phase II - STH 35 Off-Road Trail	St Croix County	\$754,422
This project includes 1.23 miles of off-road trail along State Highway 35 and 0.98 miles of on-road pavement striping and bicycle signage along River Road. This trail section will allow homes to access this particular facility and will provide pedestrian/bicycle access to the Village of North Hudson and City of Hudson schools, libraries, commercial/shopping facilities, community festivals and local, county and state park facilities.		
Arbor Vitae USH 51 Bike and Pedestrian Trail	Town of Arbor Vitae	\$1,364,492
This project is a 1.1 mile long, 10 foot wide, asphalt path for bicycling and pedestrian use on the east side of USH 51 from Terry Drive north to Chippewa Forest Road.

Funding for his project will extend the sidewalk approximately 1,565 feet from high/middle school to Glass Road.

Village of New Glarus RRFBs	Village of New Glarus	\$73,939
The Village of New Glarus and New Glarus School District are applying for TAP grant funds to install Rectangular Rapid Flashing Beacons (RRFBs) at four important pedestrian crossings in New Glarus. The first three RRFBs would be located along 2nd Street adjacent to the New Glarus School District's Elementary School, Middle/High School, and Athletic Complex. The fourth RRFB would be located across State Highway 69 at the Sugar River State Trail crossing.		
Safe Routes to School Corridor Sidewalk Network Expansion	Village of Roberts	\$573,600
There are five Safe Route to School corridors where pedestrian infrastructure is significantly needed within 1/4 mile of the school. The proposed sidewalk network expansion will connect a park, a mobile home park and multiple neighborhoods to the school and the added curb extensions will allow travel while providing safe locations for students and community members to cross Division Street, the main arterial route in Roberts.		
Highway 57 Multi Modal Trail	Village of Sister Bay	\$906,390
Funding for this project will create a 4,500' multi-modal trail parallel to STH 57 from STH 42/57 to the intersection of Northwoods Drive.		
Spencer Sidewalks and Crossings	Village of Spencer	\$174,280
This project proposes installing improvements based on the Spencer SRTS Plan and Village recommendations. The improvements include school zone signage and amber beacon assemblies, Rectangular Rapid Flashing Beacons sign (RRFBs) assemblies, bike racks at multiple public destinations, additional street lights, a speed table to reduce vehicular speeds, and a variety of signage improvements to the school zones.
