1. Application Type: Original – Apply for a new IFTA account in Wisconsin.

FEIN Change – Update your FEIN number. Must include an IRS FEIN confirmation letter. Requires a new license and \$3 fee.

Address Change – Update your physical or mailing address. Physical address changes require

additional proof of residency to be submitted. Requires a new license and \$3 fee. **Additional Decals** – Order additional IFTA decals. Requires a \$2 fee per vehicle. **Replacement License** – Order a replacement IFTA license for active accounts.

Reinstatement – Submit reinstatement fees and required items to restore your account to a good

- 2. Start Operations Date: The date you intend to start operation. This is the date in which you will be liable for record keeping and filing quarterly tax returns.
- Federal Employer Identification Number: The tax ID number issued by the Internal Revenue Service. Individuals and corporations can obtain a FEIN at www.irs.gov or by calling 1-800-829-4933.
 OR

Social Security Number: Can be used if you are a sole proprietor with no employees and are not required to obtain a FEIN. This number will print as your IFTA license number.

- **4. US DOT Number**: The number assigned by the Federal Motor Carrier Safety Administration for Commercial For-Hire & Private carriers who operate vehicles over 10,000 lbs. More information at safer.fmcsa.dot.gov or 1-800-832-5660.
- **5. Licensee Legal Name**: Business names must be registered with the Wisconsin Department of Financial Institutions. Individual names must match the exact name on your Driver's License.
- **6. IRP Account Number or Exemption:** The IRP account number issued by the jurisdiction in which your vehicles are registered. If no IRP account, an IRP Exemption must be listed: Bus, Farm Plate, 30-mile, Logging, Municipal, Owner/Operator, Leased, Special Plate or Transporter Plate.
- **7. Business Type:** List your operation type. Corporations and businesses must provide the owners, partners, corporation officer or member information. Attached additional sheets if needed.
- 8. Physical Address: The address where records are kept for the licensee's vehicles.
- 9. Mailing Address: If different from the physical address, all IFTA credentials, letters and forms will be mailed to this address.
- 10. Account Phone: Phone number for any question on the account.
- 11. Account Email: Email for questions on the account and where automated email notices will be sent.
- **12. Contact Person:** The name of the individual filing your application.
- **13. Contact Person Phone Number and/or Email**: The contact information in case there are questions regarding the application, if different than the account contact.
- **14. Permit Service Contact Name:** If using a Permit Service, enter the name of the contact person who is providing the service. Power of Attorney is required if a permit service is used.
- 15. Permit Service Contact Information: Enter the phone number and/or email of the Permit Service.
- 16. Fuel Types: Indicate the type of fuel your vehicle(s) use. Quarterly reports are required for each fuel type marked.
- 17. Bulk Fuel Storage: Indicate the jurisdiction(s) where you maintain bulk fuel.
- 18. Fee Calculations:
 - a. Application Fee: \$15.00 fee for original applications, reopened accounts and late renewals.
 - b. License Fee: \$3.00 fee for an original application, address change, or replacement license.
 - **c. Number of Vehicles Requiring Fuel Decals:** \$2.00 fee for each vehicle. Refunds are not available for unused decals.
 - **d.** Additional Decal Order: \$2.00 fee for additional decals.
 - e. Reinstatement Fee: \$25.00 to reinstate IFTA & \$25.00 to unsuspend for each IRP fleet.
 - f. Total Fee: Total fees due for your application.
