

# Project location





- US 45 importance
  - Regional route for truck and passenger vehicles
  - Primary link between Oneida and Vilas Counties
  - US 45 is an over-sized over-weight route for freight movement
- WisDOT's objective is to ensure the safe and efficient operations of the state's highway system while supporting local access

#### Purpose and need

- Identified needs
  - Deteriorating pavement and curb and gutter
  - Existing curb ramps do not meet ADA (Americans with Disabilities Act) standards
  - Drainage culverts and a cattle pass are in poor condition
  - Some drainage features (storm drains) are showing signs of deterioration and erosion
  - Poor drainage conditions (ponding) at the Anderson Street intersection

#### US 45 proposed improvements

- Pavement resurfacing with additional improvements best addresses the project needs
  - Balances level of investment in the roadway system while achieving added pavement life
- Implementing a cycle of well-timed pavement maintenance ensures that the taxpayers' investment continues to be maximized

#### US 45 proposed improvements

- Improvements recommended to keep traffic moving safely and efficiently
  - Mill and overlay of the asphaltic pavement
  - Upgrade curb ramps to meet ADA standards
  - Replacement of deteriorated curb and gutter
  - Replacement of six culverts
  - Replacement of a cattle pass near WIS 32 with a smaller drainage culvert



- Spot inlet and drainage repairs to address deterioration and erosion
- Installation of a drainage inlet at the Anderson Street intersection to eliminate water ponding
- New pavement marking including installation of centerline rumble strips in the rural areas

#### Curb ramp improvements

- All intersections will be improved with new curb ramps to meet ADA standards
- Curb ramp bump outs are planned to help meet standards while minimizing impacts
  - East School Street
  - West School Street



#### Real estate needs

- Minor permanent fee and temporary limited easements are needed
  - Curb ramp improvements
  - Culvert replacements
- Acquisition process
  - WisDOT will acquire real estate
  - Individual property owner meetings will be held
  - Begin real estate acquisitions in fall 2020
- Landowner rights brochure on the project website

#### Proposed construction staging


- Maintaining safety and mobility are important during construction
- Proposed traffic impacts
  - Single lane closures with flagging conditions
  - Shoulder and parking lane closures during paving work
  - Pedestrian staging during curb ramp work
  - Local and emergency access will be maintained
- Begin work after Independence Day

#### Current project schedule

- Local official meetings September 2019, December 2019, March 2020
- Public involvement meeting May 2020
- Preliminary plans June 2020
- Final environmental document July 2020
- Final right of way plat August 2020
- Right of way acquisition Fall 2020 to spring 2022
- Final plans February 2022
- Construction Summer/fall 2022
