## Purpose


Our objective is to gather your input about proposed improvements, discuss traffic management, and other project related information.

#### Purpose and need for improvements

US 51 is a National Highway System (NHS) route providing connections to the region, state, and nation. US 51 is also a major north-south route connecting local tourism destinations with the rest of the state.

Needs identified along this stretch of US 51 include:

- Deteriorating asphalt pavement
- Deteriorating curb and gutter
- Curb ramps do not meet current Americans with Disabilities Act (ADA) standards
- Storm sewer inlets in need of repair



## Project Map

#### **Proposed improvements**

Proposed improvements include:

- Remove the existing asphalt pavement and replace with new Hot Mix Asphalt
- Remove and replace the curb and gutter
- Remove and replace curb ramps to meet ADA standards
- Spot repair of storm sewer inlets and manholes
- Replacement of existing pavement markings

## **Proposed traffic impacts**

Construction is currently scheduled to begin in 2026 but could begin as early as 2023.

During construction US 51 will remain open but lane shifts and flagging operations will be present during much of construction. On-street parking will be prohibited during construction. Access to homes and businesses will be maintained throughout construction. However, temporary driveway closures (one day or less) will be necessary during parts of the construction process. The contractor will contact homeowners and businesses in advance before closing a driveway. Temporary pedestrian detours will also be implemented during curb ramp/sidewalk work.

#### **Real estate**

Temporary Limited Easements will be purchased at most curb ramp locations to give crews work space to construct the new curb ramp and shape the area behind the sidewalk to better blend into the new ramp.

Small amounts of permanent right of way will be purchased at some of the curb ramp locations. The current sidewalk needs to be shifted to meet accessibility standards at these locations.
