Purpose

The purpose of the letter and this supplemental information is to solicit the public's input regarding the proposed improvements as well as informing residents of the project's timing and impacts to traffic during construction.

Project Information

The Department of Transportation is proposing to improve 11.1 miles of WIS 21 between the Juneau County Line (Wisconsin River Bridge) to WIS 13 in Adams County.

The existing pavement is showing signs of distress with longitudinal and transverse cracking, rutting, and patching. The structure over the Big Roche A Cri Creek is showing signs of distress such as concrete spalling. There are three box culvers that are in poor condition with failing concrete to steel connections and corrosion. To preserve the roadway and to minimize the overall life cycle cost to the WIS 21 corridor the Wisconsin Department of Transportation proposes to do a pavement rehabilitation project on WIS 21.

Proposed improvements include:

- Mill and overlay the asphalt pavement
- Replace three existing box culverts near the Wisconsin River
- Rehabilitate the bridge over the Big Roche A Cri Creek
- Replace guardrail at select locations.
- Add 5-foot paved shoulders from North Shore Drive to the Big Roche-A-Cri bridge and from Lake Drive to Spruce Drive in Arkdale

Proposed traffic impacts

WIS 21 will remain open to traffic during construction. Motorists can expect to encounter single lane closures using flagging operations during the mill and overlay operation. Temporary traffic signals with single lane closures will be used for the replacement of three box culverts and for the structure repairs to the Big Roche A Cri Creek bridge.

Construction is currently scheduled for 2027.


