### **Purpose**

The Wisconsin Department of Transportation (WisDOT) is in the process of developing plans for proposed improvements on approximately 14.4 miles of WIS 22 in Waushara and Portage counties. The purpose of this handout is to provide information regarding the proposed improvements, describe the potential impacts, and offer an opportunity for public comment.


Your comments assist us in developing a project that will serve the needs of the traveling public as well as the needs of the local community and are welcomed and appreciated throughout the design process.

The meeting will begin at 5:00 pm. There will be a short presentation at 5:30 pm. The remainder of the meeting will follow an open house format for you to talk with project staff. You are encouraged to meet with project staff, view exhibits, and discuss proposed improvements.

# **Project location**

The project is located on WIS 22 from WIS 21 to the Portage and Waupaca County line. WIS 22 is in the city of Wautoma, village of Wild Rose, the towns of Wautoma, Rose, and Springwater in Waushara County, and the town of Belmont in Portage County, WI. Most of WIS 22 within the village of Wild Rose is excluded from this project.

# **Project Information**

WIS 22 project length is approximately 14.4 miles and serves as a minor arterial. This portion of WIS 22 is a two-lane highway with urban and rural segments. The urban segment in the city of Wautoma has one 12-foot wide lane in each direction. Paved shoulders vary from 3 feet to 12 feet wide on left- and right-hand sides. The rural segment has one 12-foot wide lane in each direction. Total shoulder width varies from 3 feet to 9 feet, of which 3 feet is paved. There is an existing bridge structure B-69-0037 that will include guardrail replacement but no work on the structure. There is also a section of existing guardrail between County AA and Hudziak Road that will remain in place. Most of WIS 22 within the village of Wild Rose is excluded from this project.

The purpose of the proposed action is to preserve the roadway assets and minimize the overall life cycle cost of the corridor. This can be accomplished by addressing the following needs:

- Roadway deficiencies
- Drainage system deficiencies
- Safety

#### Need:

#### Roadway deficiency

The existing WIS 22 pavement is showing signs of distress with significant horizontal cracking, alligator cracking, rutting, and transverse cracking. These cracks allow water and deicing chemicals to enter the pavement and accelerate the deterioration of the roadway corridor.

#### **Drainage system deficiencies**

Sections of curb and gutter and drainage flumes at the Royal Oak Drive intersection and County O intersection are deteriorated. Several culverts within the project scope are deteriorating and nearing the end of service life including 10 cross pipes, culvert C-69-9002, and 4 active or former cattle passes or culverts.

#### Safety

The existing guardrail at the bridge over the Wautoma Pond at B-69-0037 does not meet current standards, creating a potentially dangerous situation for motorists.

The following improvements are proposed to address the project needs. The proposed project is to mill the existing distressed pavement and overlay new asphaltic pavement on WIS 22. From the beginning of the project to the southern limits of the village of Wild Rose, the project proposes milling 4 inches of existing asphalt pavement and overlaying 4 inches of new Hot Mix Asphalt (HMA) surface. From the northern limits of the village of Wild Rose to the end of the project, the project proposes milling 4 inches of existing asphalt pavement and overlaying 4.5 inches of new HMA surface. The proposed road profile would have a grade raise of 0.5 inches north of Wild Rose to the end of project. The mill and overlay would exclude the village of Wild Rose. Additional project work would include:

- Widening the shoulders from 3 feet to 5 feet from the beginning of project to Royal Oak Drive and from the northern village of Wild Rose limits to County A
- Replacing the guardrail at B-69-0037 over Wautoma Pond
- Replacing culvert pipes
- Replacing culvert pipe C-69-9002 with a concrete box culvert
- Replacing small sections of curb and gutter at some intersections
- Installing centerline rumble strips

- Installing shoulder rumble strips
- Connecting sidewalk to the WIS 22 shoulder at one location

A meeting was previously held with local officials and their feedback is under consideration by the project team.

## **Proposed traffic impacts**

Construction is currently scheduled for 2031 but could occur as early as 2028. The work is anticipated to take most of the construction season.

During construction, WIS 22 will be closed to through traffic for construction of the box culvert near the fish hatchery. Once the box culvert is completed, WIS 22 will be open to traffic with single lane closures with flagging operations and lane shifts. Motorists can expect some delays to occur.

Short-term temporary driveway closures will be necessary during parts of the construction process. Homeowners and businesses will be contacted in advance before closing a driveway.

#### Real estate

Additional right of way will be required for this project. The box culvert replacement of structure C-69-9002 near the fish hatchery will require permanent fee and temporary easements on both sides of WIS 22. WDNR owns both sides of the road at this location so coordination will be completed with WisDOT and WDNR. WisDOT expects to begin real estate acquisition later in 2025.
