WIS 23 public involvement meeting (PIM) scheduled for October 12

The Wisconsin Department of Transportation (WisDOT) will have a public involvement meeting on Thursday, October 12, from 5 to 7 p.m. at the University of Wisconsin-Fond du Lac Large Group Instruction (LGI) room. The purpose of the meeting is to discuss the future of WIS 23 from the city of Fond du Lac to the city of Plymouth in Fond du Lac and Sheboygan counties. WisDOT and the Federal Highway Administration (FHWA) intend to prepare a new Limited Scope Supplemental Environmental Impact Statement (LS SEIS) for this project. The public is encouraged to attend the meeting, ask questions and offer comments.

The meeting will have an open house format with a short presentation at 5:30 p.m. More information on the project can be found online at:

Additional study being performed

June 2011 litigation prompted WisDOT and FHWA to prepare a draft and final Limited Scope Supplemental Environmental Impact Statement (LS SEIS) and a Record of Decision (ROD). The final LS SEIS/ROD was approved on March 17, 2014. In May 2015, the United States District Court for the Eastern District of Wisconsin issued a decision and order vacating the March 17, 2014 ROD. The subsequent appeal was dismissed for procedural reasons. The new LS SEIS that WisDOT and FHWA are preparing will address the issues raised in that decision.

The new LS SEIS will:

- Update the traffic forecast and explain the methodology used to develop it.
- Explain the role of demographic data in traffic forecasts.
- Evaluate and provide additional analysis, if needed, on any new or changed impacts to the human and natural environment since the 2014 final LS SEIS.
- Review the evaluation of reasonable alternatives.

The draft LS SEIS is planned for release in early 2018 and will be followed by a public hearing.


