Purpose of the handout

The Wisconsin Department of Transportation (WisDOT) is in the process of developing plans for proposed improvements along US 151 and WIS 55 in Calumet County. The purpose of this handout is to provide information regarding the purpose and need for the improvements, explain the proposed improvements, describe the potential impacts it would have on the community, and offer an opportunity for public comment.


Public input/comments

Your comments assist us in developing a project that will serve the needs of the traveling public as well as the needs of the local community and are welcomed and appreciated throughout the design process. Purpose and need for roadway improvements

Eight culverts along the project are deteriorating, and if not replaced will continue to deteriorate causing additional future maintenance costs.

Below is a map outlining the culvert locations:



Proposed improvements

- Removing the deteriorating culverts and replacing them with new hydraulically-sized structures
 - The proposed replacement structures consist of pipe culverts, box culverts, and one bridge structure.
- Replacement of any existing guardrail within the limits of the culvert replacements

Proposed traffic impacts

The project will be closed to through traffic and a detour route will be posted. Access to adjacent properties and for first responders will be maintained during construction. The contractor will be required to notify homeowners and businesses prior to construction.

- The proposed detour route is as follows:
 - US 151: County HHH and County C
 - WIS 55 (structures south of County E): US 151 to County E
 - WIS 55 (structures north of County E): County E to WIS 114

Schedule

- Public comment period June 20 July 8, 2022
- Environmental document August 2022
- Real estate acquisition 2023/2024
- Design completion
 November 1, 2024
- Construction 2025

Real estate

Right-of-way acquisition will be required at each of the culvert replacement locations. The proposed structure replacement approximately 150' south of Enterprise Street will require acquisition of the residential duplex property adjacent to the highway.

Section 4(f) Property

The Federal Highway Administration (FHWA) has regulations governing the use of land from publicly owned parks, recreation areas, wildlife and waterfowl refuges, and public or private historic sites. These sites are called Section 4(f) properties. The Stockbridge Legion Fireman Community Park, which is adjacent to the project, is a Section 4(f) property. As a result of proposed right-of-way acquisition necessary for the proposed improvements, WisDOT intends to make a *de minimis* impact determination.
