Purpose of handout

The Wisconsin Department of Transportation (WisDOT) is in the process of developing plans for proposed improvements on 10.3 miles US 8/US 141 in Marinette County The purpose of this handout is to provide information regarding the proposed improvements, describe the potential impacts it would have on the community, and offer an opportunity for public comment.


Project location

US 8 from just south of County R near Pembine to the Michigan State Line in Marinette County. The project is split into two portions:

- US 8 north-south segment that runs contiguous with US 141 for approximately 8.2 miles.
- US 8 east-west segments with a length of approximately 2.1 miles.

Purpose and need

The purpose of the project is to extend the service life and improve the riding surface of US 8. Currently, the existing pavement is showing signs of deterioration including longitudinal and transverse cracking. The pavement on the north-south segment experiences tenting during the winter months, resulting in rough riding roadway. The pavement surface has reached the end of its useful life and should be repaired to preserve the integrity of the riding surface and the underlying base. The existing beam guard system does not meet current standards and should be replaced.

Proposed improvements

Proposed improvements on the US 8 north-south segment include:

- Mill two inches of the existing surface and place an asphalt under seal on the milled surface to help prevent the winter tenting of the highway pavement, then pave two inches of hot mix asphalt
- Widen existing shoulders from 3' to 5'
- Replace beamguard
- Install centerline and shoulder rumble strips
- Pavement marking

Proposed improvements on the US 8 east-west segment include:

- Mill two inches of the existing asphalt and pave four inches of hot mix asphalt
- Widen existing shoulders from 3' to 5'
- Replace beamguard
- Flatten slopes north of the intersection of US 8 with Geldmeyer Road/Old US 8.
 Beamguard will be removed at Geldmeyer Road following slope work.
- Culvert rehabilitation
- Install centerline and shoulder rumble strips
- Pavement marking

Traffic impacts

US 8 will remain open to traffic during construction with lane closures and flagging operations.

Schedule

- Public involvement: Winter 2022
- Environmental Document: Winter 2022
- Project design: 2022-2024
- Final Design: Summer 2025
- Construction currently scheduled in 2026
 - o Could be advanced to 2025 if funding becomes available

Real estate

No right of way is anticipated as part of the project.
