Purpose of handout

The Wisconsin Department of Transportation (WisDOT) is developing plans for the proposed improvements on WIS 124 from the village of Lake Hallie to the city of Chippewa Falls in Chippewa County. The purpose of this handout is to provide information regarding the proposed project, describe the potential impacts it would have on the community, and offer an opportunity for public comment.

Project location

The project limits run for 2.8 miles of WIS 124 from the village of Lake Hallie to the city of Chippewa Falls between County OO and Business 29 in Chippewa County.



Proposed improvements

The purpose of the project is to address the deterioration of 2.8 miles of the existing WIS 124 roadway surface and the substandard guardrail and curb ramps to maintain a safe and efficient transportation system between the village of Lake Hallie and the city of Chippewa Falls. See the attached project location map and preliminary plans. The following work is proposed on WIS 124:

- Milling the existing asphalt pavement from 1500 feet north of County OO to 1300 feet south of Business 29 and overlaying it with asphalt.
- Performing spot concrete pavement repairs at the intersections of Park Avenue and Woodward Avenue.
- Upgrading curb ramps, guardrail, and pavement markings.
- · Regrading ditches at select locations.
- Culvert Lining at select locations.

Proposed traffic impacts

During construction, WIS 124 would remain open to local and through traffic using single lane closures and flagging operations. There may be very short periods that driveway access is disrupted for paving. The contractor will provide advanced notice of any access restrictions.

Schedule

Construction is currently scheduled for 2024 (advanced from 2028).

Real estate

Real estate acquisition would not be required.


