### **Project Location**

The Wisconsin Department of Transportation (WisDOT) is planning pavement improvements for 2.8 miles of WIS 124 in Chippewa County.

### **Route Importance**

WIS 124 is the main north-south route through the village of Lake Hallie and city of Chippewa Falls.

#### Traffic

- 13,200 vehicles per day (2017)
- 7.7% Trucks





#### **Purpose and Need**

The purpose of the project is to address the deterioration of the existing roadway and the substandard guardrail and curb ramps to maintain a safe and efficient transportation system.

The primary need for the project is to improve the deteriorating WIS 124 roadway surface.

A secondary need for the project is to improve the substandard guardrail and curb ramps. Addressing poor drainage in several ditch locations and rehabilitating an exiting culvert with lining is also included as a secondary need.



### **Alternatives Considered**

Alternative A - No Build

Maintain the existing facility with no improvements other than routine maintenance.

<u>Alternative B – Resurfacing</u> Mill the existing asphalt pavement, place an overlay of new asphaltic pavement, and perform spot concrete pavement repairs.




### WisDOT Recommended Alternative

Alternative 1 - No Build

This alternative would result in continued deterioration of the roadway and hazardous travel. This alternative would not meet the purpose and need and is not preferred.


<u>Alternative 2–Resurfacing (WisDOT Recommended)</u> This alternative would meet the purpose and need and is preferred.



# **Proposed Improvements**

- Milling and overlaying the existing asphalt pavement.
- Performing spot concrete pavement repairs at the intersections of Park Avenue and Woodward Avenue.
- Upgrading curb ramps, guardrail, and pavement markings.
- Grading ditches for improved drainage at select locations and pipe culvert lining.
- During construction, motorists can expect single lane closures and flagging operations.
- No real estate anticipated.





## **Project Timeline**


- •September 13, 2021: Local officials meeting held.
- •Now until October 15, 2021: Public comment submission.
- •Nov 1, 2021: Final environmental document submission
- •August 1, 2023: Final plans, specifications and estimates submission.
- •2024: Construction. Advanced from 2028.


