








The presentation will follow the outline shown here. First, we will discuss the project location; second, the project purpose and need; third, the proposed improvements; fourth, real estate needs; fifth, traffic control and staging; sixth, the project schedule; seventh, project contacts; and finally, public comment.



This construction project will make improvements at spot locations of curb ramps along three highway segments in the cities of Eau Claire and Altoona and town of Washington. The three segments consist of WIS 312 from Old Wells Road to Business 53, US 12 from Truax Boulevard to Mayer Road and WIS 93 from East Hamilton Avenue to Deerfield Road.

Currently, there are up to 28,500 vehicles that travel US 12 each day; up to 24,900 vehicles that travel WIS 312 each day; and up to 23,000 vehicles that travel WIS 93 each day.

### **Purpose and Need**

- Substandard pedestrian curb ramps
- Inconsistent layout of pedestrian crossings









The primary need for this work is that not all of the existing pedestrian curb ramps meet Americans With Disabilities Act standards. In order to improve the curb ramps to current standards, small amounts of acquisition for right of way and temporary easements will be required in select locations.

There are also some locations where pedestrian crossings are not consistent or not fully provided where needed or desired. These issues will also be addressed with this project.






Proposed improvements for each highway segment consist of upgrading and constructing pedestrian curb ramps to meet current ADA standards. This will include reducing ramp slopes and installing detectable warning fields where they are missing.



There will be several minor FEE, or permanent, acquisitions of new right of way, where land ownership will change. These areas are required to ensure the reconstructed curb ramps are within roadway right of way. Temporary limited easements will also be needed for grading when matching into the existing ground.



WIS 93, WIS 312 and US 12 will remain open during construction. During curb ramp construction, some sections of sidewalk will need to be closed. Pedestrians will be detoured, and temporary ramps and crossings will be utilized to maintain access during the project.

#### **Schedule**

- Right-of-way acquisition
  - March 2024 to August 2025
- Utility coordination
  - May 2024 to August 2025
- Final plans submittal
  - August 2025
- Construction
  - **2026**



Looking at the remaining project schedule, the real estate acquisition period will begin around March 2024 and be completed by August 2025. Utility coordination will take place once the project plat has been finalized, recorded and completed prior to the final plan submittal in August 2025. We anticipate minor, if any, impacts to utilities. Construction is scheduled for 2026.
