# Purpose of the meeting

The objective of today's meeting is to obtain your input on the identified needs and proposed improvements along US 53 between County B and WIS 64 in the towns of Tilden, Woodmohr and Bloomer in Chippewa County.


#### Purpose and need for roadway improvements

The primary project purpose is improving the condition of the pavement on US 53 to provide motorists with a highway that both meets safety standards and provides a high level of service.

The project need is needed to address US 53's deteriorated condition. In its current state, the existing pavement on US 53 and at the WIS 40 and WIS 64 interchanges is exhibiting signs of deterioration in the form of cracking and rutting. Also, the County B, County Q and WIS 40 bridges over US 53 are deteriorating. To meet the project need, a proposed solution must attempt to correct these key issues.

If no action is taken, the pavement structure life will be significantly reduced, and the ride quality will continue to worsen. The original US 53 pavement was placed in the 1970s and last resurfaced in the mid-2000s. The pavement is nearing the end of its service life.

# **Recommended improvements**

- Rehabilitation of the pavement is no longer cost effective and pavement replacement is warranted to ensure safe maintenance of traffic on this high priority route.
- The existing pavement will be removed and replaced with new concrete pavement and a new aggregate drainage layer on US 53 and the WIS 40 and WIS 64 interchange ramps. The pavement also will be replaced along WIS 40 and WIS 64 between the ramps.
  - The existing roadway alignment and number of travels lanes will be maintained.
  - No intersection or interchange modifications are warranted by current safety conditions and existing intersection configurations are proposed to be maintained.
- Repairs to US 53 overpass bridges on County B, County Q (near 157<sup>th</sup> Avenue) and WIS 40.
- Drainage culvert replacements will be completed.
- Guardrails will be replaced throughout the project.
- Pavement marking and shoulder rumble strips will be replaced.
- Right-of-way fencing will be removed and replaced.
- The recommended improvements are subject to approval of the final environmental document.

#### **Real estate**

Work is anticipated to occur within the existing right of way.

New right-of-way fence will be placed inside the existing right of way (typically 3-feet). If the fencing helps to contain livestock, please contact WisDOT so that we can coordinate with you during replacement of the fence.

## **Proposed traffic impacts**

Construction of US 53 is proposed to start in spring 2025 and extend through fall 2026 to accommodate staged construction and minimize traffic delays along US 53. Construction on temporary median crossovers may begin in fall 2024.

During construction, motorists can expect to encounter single-lane closures and bidirectional traffic conditions on each side of US 53. Speeds will be reduced to 60 miles per hour.

Construction of temporary crossovers is proposed to manage traffic movements between northand southbound US 53 during construction. Temporary crossovers also will be constructed to provide access at the interchanges.

#### Interchanges

During construction of the interchange ramps at WIS 40 and WIS 64, ramps will be closed for designated periods to allow for pavement replacement.

- Full interchange closures will not be allowed.
- Ramp closures will not occur at consecutive interchanges at the same time.

Along the crossroad through each interchange, traffic will be managed as follows:

- County B: During bridge deck repair work, through traffic (east-west) will always be maintained along County B with a single lane and temporary traffic signals.
- WIS 40: Through traffic (east-west) will always be maintained with single-lane closures and bidirectional traffic conditions on WIS 40.
- WIS 64: Through traffic (east-west) will always be maintained along WIS 64 with a single lane and temporary traffic signals.
