Purpose

Our objective is to update you on the project scope and schedule and obtain your input on the identified needs, proposed improvements and traffic impacts along US 53 between County Y and County M (southbound) in the town of Gordon, all in Douglas County.


A meeting with local officials was held on July 25, 2023.

The purpose of the project is to preserve the roadway asset and minimize the overall life-cycle cost of the corridor. Additionally, drainage and roadside safety needs will be addressed.

Other identified issues include:

- Culvert ends are separated and leading to poor drainage.
- Trees and brush are growing within the safety clear zone along the sides of the roadway.
- Existing guardrail does not meet current crash standards.

Project Information

We are proposing to resurface approximately 3.0 miles of existing concrete pavement with new asphalt at a depth of 4 inches along US 53.

Other proposed improvements include:

- Making concrete pavement repairs
- Repairing or replacing culverts
- Clearing roadside brush and trees
- Replacing guardrail
- Placing pavement markings

Proposed traffic impacts

Construction is currently scheduled for the summer of 2025 and estimated to take three months to complete.

US 53 will remain open to traffic during construction. During construction, the roadway will be constructed under traffic using single-lane and shoulder closures.

Local, business and emergency access will be maintained. However, temporary side road closures will be necessary during parts of the construction process.

Real estate

No real-estate acquisition needs are expected.

Access Modifications

No driveway or side road access modifications along the project are planned at this time.
