

# **US 63: Resurfacing Project**

City of Cumberland, Barron County December 2021

### Purpose of the meeting

To update and discuss the proposed resurfacing project on US 63 in the city of Cumberland and receive public comment.

## **Project information**

The Wisconsin Department of Transportation (WisDOT) is developing plans to improve US 63 from the west junction of WIS 48 to Charrie Lane. Design work is currently underway, and final plans are expected in 2024. Construction is anticipated to take place in 2025.

The purpose of the project is to preserve and maintain the service life of US 63, including curb and gutter, provide Americans With Disabilities Actcompliant curb ramps, and to maintain the existing storm sewer inlets and sanitary manholes.

The proposed project concept includes resurfacing the existing roadway, upgrading curb ramps, making spot curb & gutter and sidewalk repairs, repairing or replacing inlets and manholes for storm and sanitary sewer.

Additional design considerations to be discussed include marking bicycle facilities and other pavement marking modifications, as well as design considerations related to historical properties.

### Access

Access to properties will be maintained within the work zone during construction, if access is temporarily unavailable due to construction activities the property owner will be notified by construction staff and alternate access will be provided. Access to US 63 would be reviewed throughout design for potential safety improvements.

## Real estate

This project will require temporary and permanent real estate acquisition. **Temporary limited easements (TLE)**, where the land remains with the property owner, will be needed for grading to match or finish lawn areas and to blend slopes for sidewalk, lawn or driveway areas. Permanent, or **FEE**, acquisition will be needed in areas where existing sidewalk is not under WisDOT ownership.

## Traffic control

During construction, US 63 will remain open to traffic; however, traffic might be reduced to one lane in each direction and controlled by flagging. Minimal delays (less than 15 minutes) will be expected. In addition, temporary parking lane closures are anticipated.


