



# WIS 37: Pavement Replacement Project

## WIS 88 to US 10, Buffalo County

Spring 2022

### **Purpose of the meeting**

To distribute information regarding the proposed pavement replacement efforts along WIS 37 and receive public input.

### **Project information**

The Wisconsin Department of Transportation (WisDOT), in partnership with the city of Mondovi, is developing plans to improve WIS 37 from WIS 88 to US 10 in Buffalo County. Design work is currently underway, and final plans are expected to be complete in summer/fall 2024. Construction is anticipated for summer 2025.

The purpose of the project is to improve the deteriorating pavement surface and safety along the corridor and evaluate the incorporation of additional bicycle and pedestrian accommodations.

The proposed project will include:

- Replacing the existing asphalt with concrete pavement.
- Adding rumble strips.
- Replacing guardrail, sidewalk, curb and gutter.
- Installing new storm sewer.

In addition, the city plans to install new water main, sanitary sewer and lighting and might add a shared-use path.

### **Traffic impacts**

WIS 37 will be closed during construction, and through traffic will be detoured via WIS 88, WIS 121, WIS 93 and US 10.

Access to residential properties and businesses located within the project limits will be maintained during construction.

### **Real estate**

Additional roadway right of way will be required to construct portions of this project. Acquisition of temporary interests for ground grading is required along most of the corridor. Some permanent interests of right of way will be required.

### **Public comments**

We encourage you to talk to the project representatives and ask questions. Attached to this handout is a sheet for your written comments and concerns about the project. Please mail any written comments about the project before May 6.

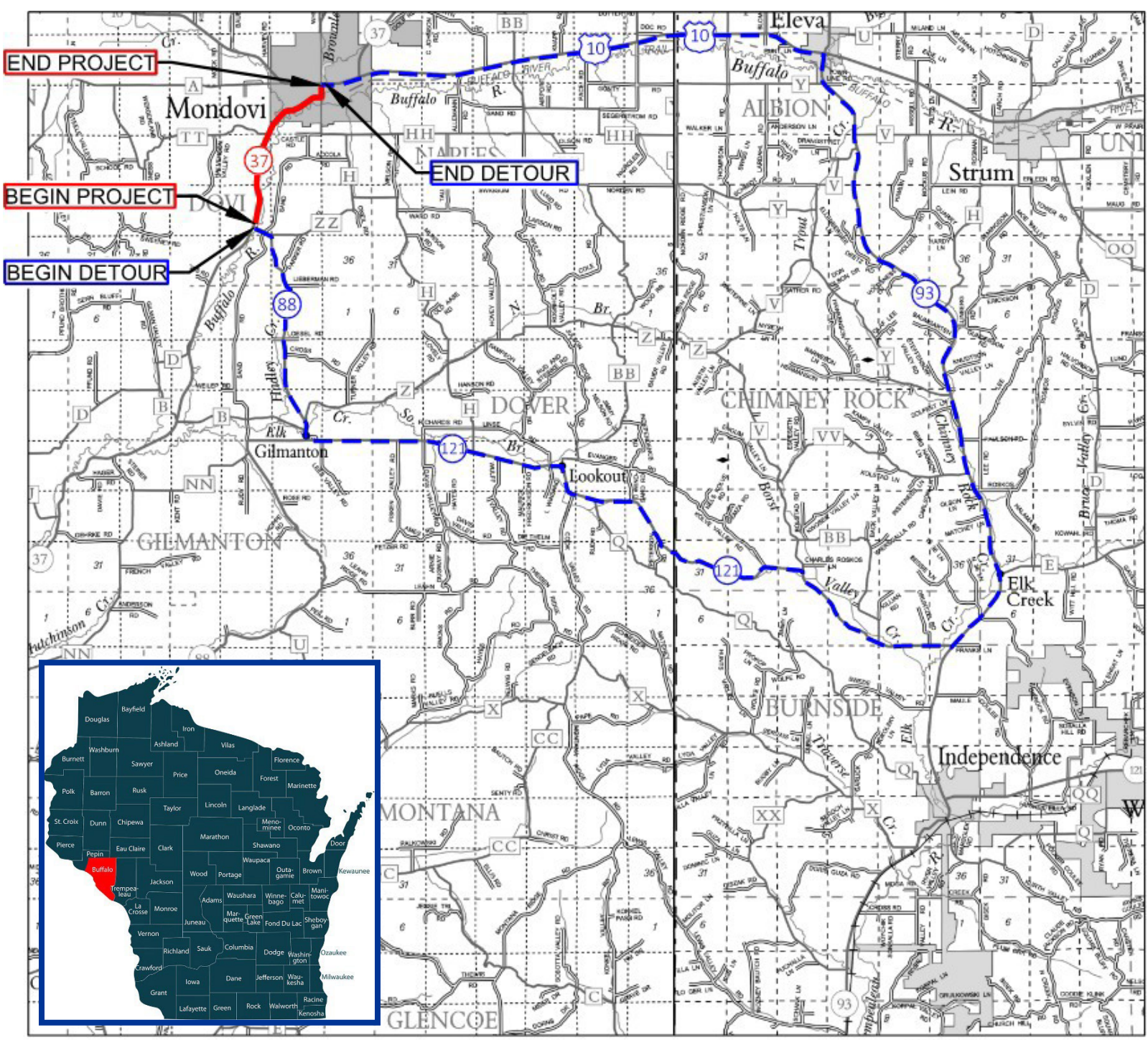
