Welcome to the Public Involvement Meeting (PIM) for the resurfacing of WIS 145 from WIS 100 (Main Street) to WIS 167 (Mequon Road). Representatives from WisDOT and the engineering design consultants are available to discuss the proposed project and address any questions or concerns. The meeting is an open house format without a formal presentation. Project-related sketches and plans are displayed at the meeting.

Project Overview

The Wisconsin Department of Transportation (WisDOT) is proposing to resurface WIS 145 from WIS 100 (Main Street) to WIS 167 (Mequon Road) in the Villages of Menomonee Falls and Germantown in Waukesha and Washington Counties (see next page of project location).

Purpose and Need

The purpose of the proposed project is to address the deteriorating pavement condition and decreasing ride quality along WIS 145, the condition of multiple deteriorating cross culverts and drainage maintenance concerns, aging traffic signal equipment, aging guardrail, and noncompliant curb ramps. The need for the project is to extend the service life of the pavement and provide a safer driving surface on WIS 145. The pavement will continue to deteriorate if no work is to be done.

Summary of Proposed Improvements

The project would mill off and remove the top two to four inches of the existing asphalt pavement and overlay the pavement with two to four inches of new asphalt from WIS 100 to WIS 167. Additionally, the following improvements are included as part of the project:

- Curb ramp improvements at the WIS 145 and Knollcrest Cir, Seven Pines Way, and Donges Bay Rd intersections.
- One guardrail removal and four guardrail replacement.
- Two cross-culvert replacement and drainage improvement, as needed.
- No changes to the number of lanes or existing geometry are proposed.
- Minor right of way acquisition for curb ramps and culvert replacement is anticipated.

Traffic Impacts

During construction, WIS 145 between WIS 100 and WIS 167 will be closed for all through traffic, however access to local businesses and residences will be maintained. Both northbound and southbound WIS 145 traffic will be detoured utilizing WIS 100 (Main Street), I-41, WIS 167 (Mequon Road).

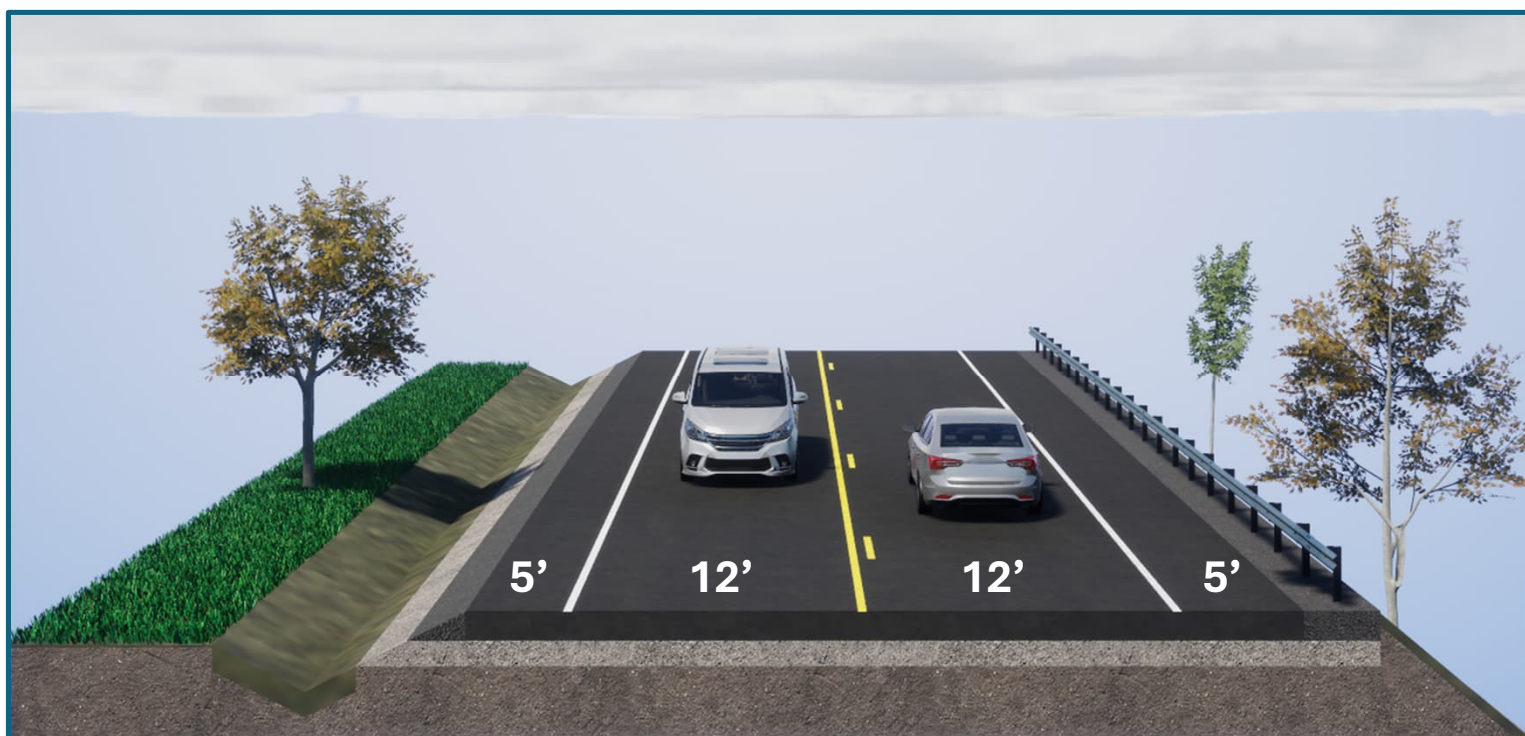
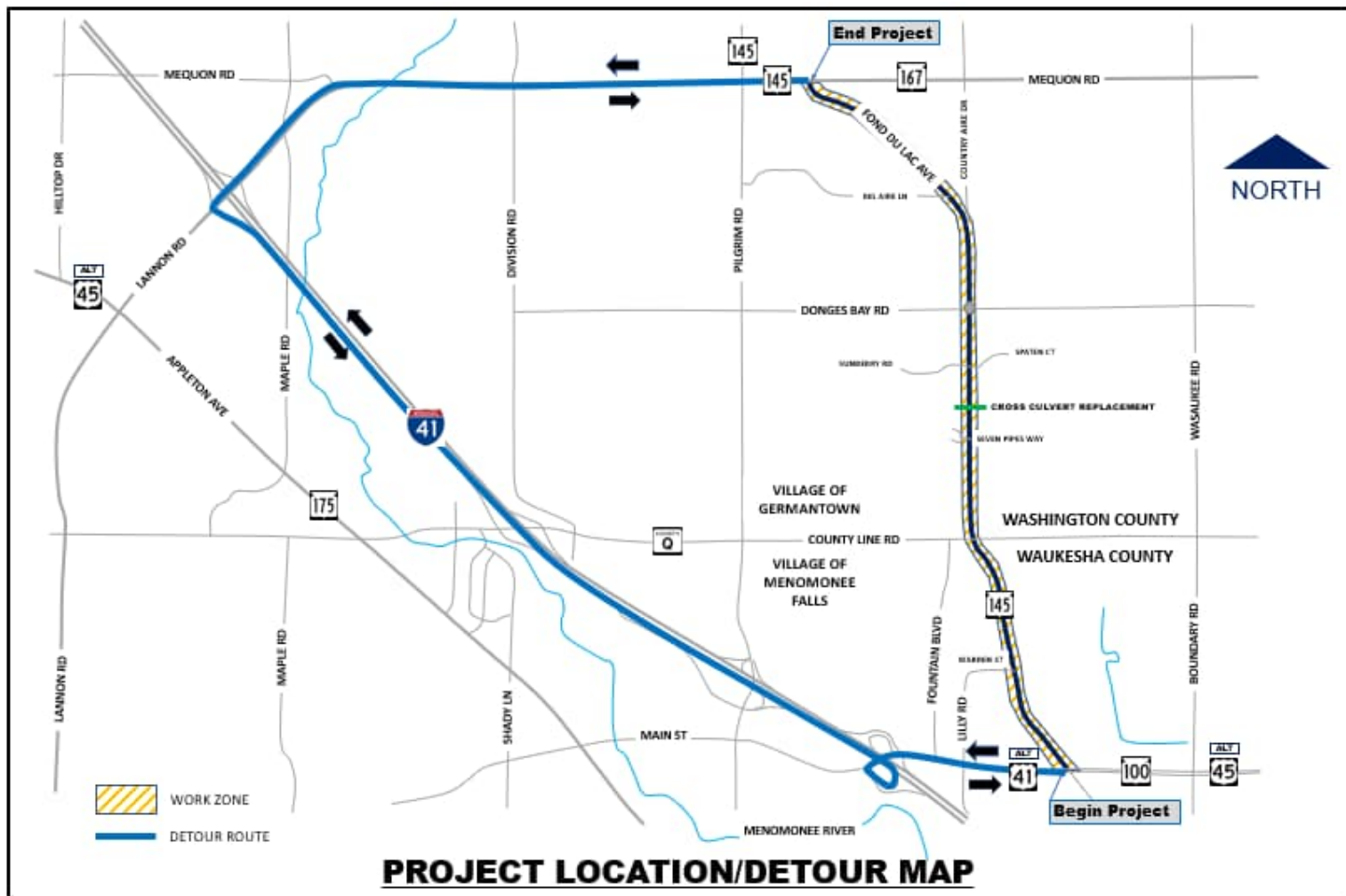
