Purpose of the meeting

The need for the project includes: deficiencies in existing pavement due to aging, rutting and cracking. Safety issues at US 14 intersections with Holt Road, WIS 59, W Butts Corners Road, and W Bullard Road.

The purpose of this project is to extend the existing pavement life by addressing the roadway surface and safety issues.

A virtual Local Officials Meeting was held on February 24, 2023

A presentation of the proposed project improvements will be played during the public involvement meeting and displays will be present for attendees to view. Project staff will be available to answer any questions related to the project.

Project information

WisDOT is proposing to improve 5.3 miles of US 14. Proposed improvements include:

- Resurfacing the existing roadway by milling off the top layer of asphalt and paving a layer of new asphalt.
- Widening paved shoulders from 3' to 5'.
- Turn lanes for both Northbound and Southbound on US 14 at Holt Road along with improved intersection geometry for Holt Road.
- High friction surface on US 14 at the WIS 59 intersection.
- A reconstruction of the W Butts Corners Road intersection. Improvements on US 14 will include: addition of Northbound left turn lane, improved horizontal geometry, vertical profile improvements with a hill cut.
- Addition of Southbound left turn lane on US 14 at the Bullard Road intersection.

Intersection improvements at Holt Road, WIS 59, W Butts Corners Road, and W Bullard Road will improve turning movements and safety as significant crashes have been identified at these intersections.

The environmental impacts for this project are still being identified including screening the project for significant archeological and historic properties.



Proposed traffic impacts

Construction is scheduled to begin in 2026.

During intersection construction work, thru traffic on US 14 and WIS 59 will be detoured utilizing WIS 92, WIS 104, WIS 59, and WIS 213. For remaining construction operations, US 14 between WIS 92 to WIS 213 will be reduced to one lane with flagging.

Construction is anticipated to complete in 2026.

Real estate

Additional right of way will be required for this project. Land acquisitions are anticipated for intersection improvements however the right of way impacts are still being determined. Preliminary impacts can be seen on the displayed exhibits. WisDOT expects to begin real estate acquisition in Fall of 2023.

Project update/next steps

Environmental study expected to be completed spring 2023.

Real estate land acquisitions expected fall 2023.

Out for bid November 11, 2025.

Construction expected Summer 2026.
