WIS 113 Pavement Replacement – County P to Lodi City Limits

The Wisconsin Department of Transportation (WisDOT) is proposing to replace approximately 3.7 miles of pavement along WIS 113 in Dane and Columbia Counties. The purpose of this project is to provide long-term improvements to the pavement, operation, and safety of the roadway. The highway was paved in 2003 and has now deteriorated to a point where replacement is required. Minor fee and temporary limited easements may be required for guardrail.

Proposed Improvements:

- Replace the pavement
- Install rumble strips along the centerline and edgeline
- Update and replace curb and gutter
- Update and replace guardrails

Traffic Impacts:

- WIS 113 is scheduled to be closed from County P in Dane County to Belin Street in Columbia County. A detour will be posted utilizing WIS 19, I-39/90/94 and WIS 60
- Access to businesses and residences will be maintained
- Construction is scheduled to begin 2028
