PROJECT INFORMATION

WisDOT is proposing to improve approximately 11.60 miles of WIS 130 from the west junction of County B to WIS 154, which was last reconstructed/resurfaced in 1994 and seal coated in 2000. See the attached project location map. The existing pavement exhibits signs of fatigue in the form of rutting, alligator cracking, and transverse cracking.

Proposed improvements include:

- 1) Extending the service life of the asphaltic pavement
 - a) Mill approximately 2" of the existing asphaltic surface
 - b) Mill and relay 3" of the existing asphaltic surface
 - c) Overlay with 3.5" of HMA pavement
- 2) Replace sidewalk and curb & gutter in Bear Valley
- 3) Improve drainage in Bear Valley with grading, new storm sewer, and new culvert pipe
- 4) Replace guardrail and end terminals at structures B-56-021 & B-56-103
- 5) New pavement markings and warning signage

PROPOSED TRAFFIC IMPACTS

Construction is currently scheduled to begin in the summer of 2027 but could begin as early as 2026 and is expected to be completed within 12-14 weeks.

WIS 130 will be detoured during construction. The planned route is WIS 130 to US 14 to WIS 58 to WIS 154. Temporary driveway closures may be necessary during parts of the construction process. Construction staff will contact homeowners and businesses in advance before closing a driveway. If you have special access needs during construction, please let us know so these can be considered as much as possible, and if needed, included in the bidding documents.

Please note that there will be another pavement improvement project on WIS 130 that is anticipated to be under construction at the same time as this project. That project goes from US 14 to the West Junction of County B, approximately 6 miles.

REAL ESTATE

A minor amount of real estate will be acquired for culvert pipe and drainage improvements.
