The Wisconsin Department of Transportation (WisDOT) is seeking public feedback on the WIS 16 bridge rehabilitation in Dodge County. The purpose of this outreach is to obtain your input on the identified needs and proposed improvements. There will be no in-person public meeting. 
Project Information

WisDOT is proposing to improve 370 feet of WIS 16 over the Chicago, Milwaukee, St. Paul, and Pacific Railroad. The project is located approximately 4.5 miles east of the city of Columbus in Dodge County in the town of Elba.

The existing structure over the railroad would have the following improvements:

- Concrete overlay of deck.
- Parapet modifications.
- Spot painting of girder ends and bearings at abutments.
- Concrete surface repair at abutments.
- · Replace southeast and southwest wings.
- · Replace existing guardrail.
- Replace concrete approach slabs and expansion joints.

During construction, the roadway would be closed to through traffic and detoured. Access would be maintained to all properties in the project area. A signed detour is anticipated to use WIS 73, US 151, WIS 33, and WIS 26. No improvements are anticipated on the detour routes.



Proposed Traffic Impacts

Construction is scheduled to begin in 2024.

If funds are available, the project could occur in 2022.

During construction, the roadway would be closed to through traffic and detoured.

Real Estate

No right of way is anticipated as part of the project.
