
# Purpose of the meeting

The objective is to obtain your input on the identified needs, proposed improvements, and detour route along 3.46 miles of WIS 28 between Ellsworth Street in Horicon and the North Junction County TW in the Town of Williamstown, Dodge County.

## Purpose and need for roadway improvements

The WIS 28 pavement is aged and showing signs of deterioration with alligator, longitudinal and transverse cracking. The project is needed to extend the service life of the pavement.

Below is a map outlining the project area:



#### **Proposed improvements**

- Milling the existing asphaltic pavement and overlaying it with 3 ½" of new asphalt.
- Replacing the existing guardrail just southwest of the WIS 28/Schwarze Road intersection
- Installation of rumble strips on WIS 28
- New pavement marking

Prior to this construction project, Dodge County Highway is being provided a Local Force Account (LFA) to conduct in-kind replacement of several culvert pipes one year prior to this project to ensure natural compaction has taken place preventing subsidence of the roadway after the mill and overlay.

## **Proposed traffic impacts**

The project will be will be closed to through traffic duration construction and a detour route will be posted. The detour route will utilize WIS 33 and WIS 67.

#### Schedule

The improvement project is currently scheduled for 2025 however it could get advanced to as early as 2023 if funding becomes available. The Local Force Account project with Dodge County for culvert pipe replacements is currently scheduled for 2022.

Access to adjacent properties and for first responders will be maintained during construction. Brief interruptions in access may occur temporarily at driveways. The contractor will be required to notify homeowners and businesses prior to construction.

No land acquisitions are expected along the project limits.
