
Purpose of the meeting

The objective is to obtain your input on the identified needs, proposed improvements, and detour route along 5.17 miles of WIS 67 between the Waukesha County Line and County MM in the Town of Ashippun in Dodge County.

Purpose and need for roadway improvements

The WIS 67 pavement is aged and showing signs of deterioration with alligator, longitudinal and transverse cracking. The project is needed to extend the service life of the pavement, improve the driving surface, and reduce future maintenance. In addition, there are three pipe culverts that are deteriorated and in need of replacement, the guard rail at the WIS 67/Davy Creek bridge is substandard and in need of replacement, and there are several curb ramps that are not up to Americans with Disability Act (ADA) requirements.

Below is a map outlining the project area:



Proposed improvements

- Milling the existing asphaltic pavement and overlaying it with 3 ¹/₂" of new asphalt
- Replacing the existing guardrail at the WIS 67/Davy Creek bridge
- Replacing three deteriorated pipe culverts
- Updating curb ramps as needed to meet Americans with Disability Act (ADA) requirements
- Replacing the existing railroad crossing surface and signals at the Union Pacific Railroad at-grade crossing

Proposed traffic impacts

The project will be will be closed to through traffic and a detour route will be posted. The detour route is still being determined, but will be finalized during the design process.

Access to adjacent properties and for first responders will be maintained during construction. Brief interruptions in access may occur temporarily at driveways. The contractor will be required to notify homeowners and businesses prior to construction.

Schedule

The improvement project is currently scheduled for 2027, however, it could get advanced to 2026 if funding becomes available.

Real estate

Minor right-of-way acquisition will be required at select curb ramp replacement locations.
