## **Purpose of the meeting**

The objective of today's meeting is to obtain your input on the identified needs and proposed improvements. The meeting will follow an open house format.

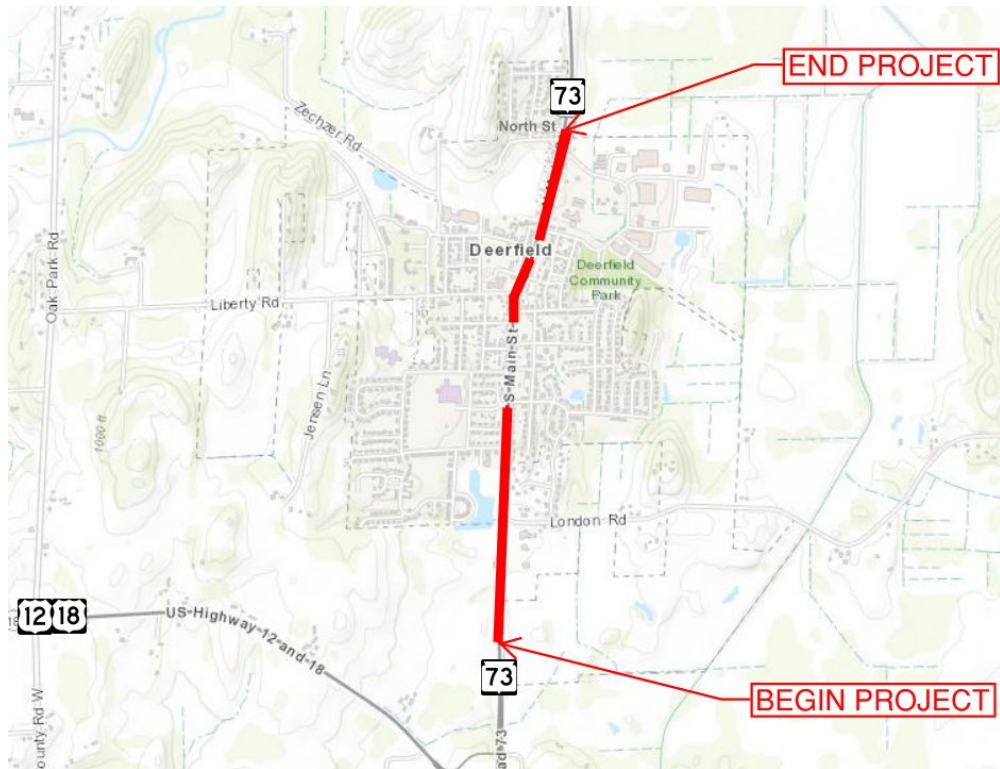
## **Project information**

WisDOT is proposing to improve 1.7 miles of WIS 73 from Shaul Lane to North Street. Proposed improvements include:

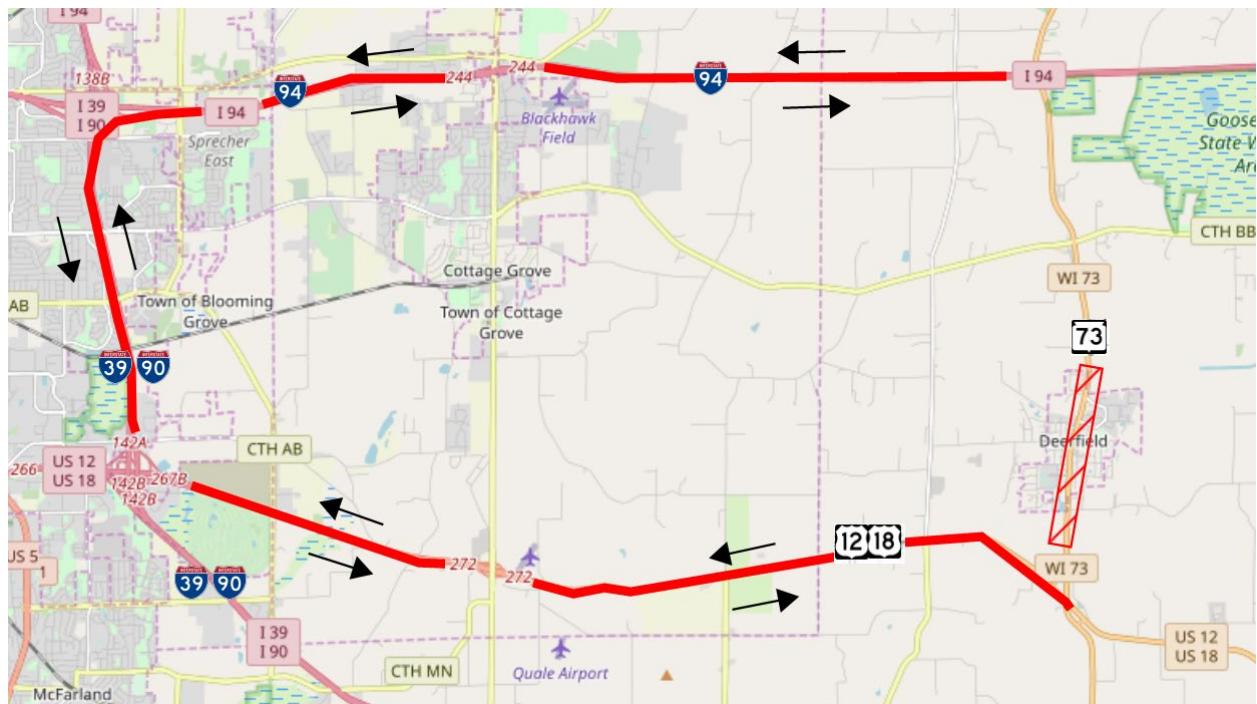
- Mill and overlay asphaltic pavement.
- Reconstruction of approximately 1,500 feet of distressed pavement areas (three areas):
  - WIS 73 between East Quarry Street and 150-feet north of Lake Street.
  - WIS 73 between South Industrial Road and 600-feet north of South Industrial Road.
  - WIS 73 between North Industrial Road to 100-feet north of North Street.
- Replacement of curb ramps to meet Americans with Disabilities (ADA) standards, where feasible.
- Installation of new pavement marking.

The improvements above help address the deteriorating pavement and curb ramps along the project that do not meet ADA standards. If not repaired, the pavement life will be significantly reduced leading to the need for premature reconstruction of the pavement.

## Proposed traffic impacts

During construction, WIS 73 is expected to remain open to traffic for most of the construction project except for the reconstruction segments of the project:

- WIS 73 between East Quarry Street and 150-feet north of Lake Street
- WIS 73 between South Industrial Road and 600-feet north of South Industrial Road
- WIS 73 between North Industrial Road to 100-feet north of North Street

Flagging operations, shoulder closures, and parking restriction will be used to manage traffic during most of the project.

A short term detour of no more than 2-weeks will be used to manage traffic during the reconstruction of the three segments listed above.

Construction is currently scheduled for completion in Fall 2023.

## Real estate

Additional right of way will be required for this project. The additional right of way will allow for the proposed curb ramps to meet ADA standards. Preliminary right of way impacts are shown on the exhibits. WisDOT expects to begin real estate acquisition in July 2020.
