

Project Location







- WisDOT proposing to improve 6.2 miles of WIS 78
- Limits Lien Court to County H
- Purpose and Need
 - The existing asphalt pavement is exhibiting signs of deterioration in the form of alligator cracking and rutting
 - Curb ramps do not meet current standards
 - The existing guardrail does not meet current standards





- Proposed Improvements
 - Resurfacing: Lien Court East School St and B-33-40 to County H
 - Milling and resurfacing Asphalt pavement
 - Pavement Replacement: East School Street to B-33-40
 - Pavement replacement including new aggregates, asphalt pavement, curb & gutter
 - Areas of sidewalk replacement
 - Storm sewer replacement
 - Upgrade curb ramps to meet current standards
 - Upgrade guardrail to meet current standards

Proposed Traffic Impacts

- During resurfacing WIS 78 will remain open to traffic utilizing flagging operations
- Short term closures at intersections are possible
- Some delays are likely
- Local and emergency access will be maintained





Proposed Traffic Impacts

- During pavement replacement WIS 78 will be closed to through traffic and detoured
- Detour route will utilize WIS 39, WIS 69 and WIS 81
- During concrete work and underground work access will be limited
- Emergency access will be maintained





Real Estate

- Majority of work will occur within existing highway right-of-way
- Acquisitions will be required in curb ramp and sidewalk areas
- Acquisition process
 - Real Estate staff will coordinate with property owners
 - Acquisition expected to begin in mid 2023
- Landowner rights information available on the project website





Environmental

Environmental assessments are being completed for this project, including evaluation of historic and archaeological resources. Through these investigations, multiple historic structures and a potential historic district have been identified within the Village of Blanchardville. Proposed project actions adjacent to these structures include resurfacing or pavement structure replacement, replacement of existing curb ramps with ADA compliant curb ramps, and sidewalk replacement. For these actions, Right-of-way acquisition and TLE would be needed. The proposed actions are not expected to modify any historic buildings or facilities with this project.
