# Purpose of the meeting

The Wisconsin Department of Transportation is proposing to improve WIS 81 in Grant County from School Street in the Village of Cassville to County Y. This project will address aged pavement that is beginning to deteriorate and will improve safety on the corridor through guardrail upgrades and rumble strips.

The objective of this public involvement meeting is to explain the project, and to obtain any feedback you may have on the proposed improvements to WIS 81.

A coordination meeting with local community officials was held on July 29, 2021.

# **Project information**

WisDOT is proposing to improve 2.5 miles of WIS 81. Proposed improvements include milling and repaving 2.5-inches of asphalt, upgrading guard rail to current standards, adding centerline rumble strips, and refreshing pavement markings.

The milling and repaving of WIS 81 will extend the pavement life, reduce maintenance costs, and deter a more costly project from becoming necessary. Additionally, the existing guardrail ends are substandard, and will not protect a driver in the event of a head-on collision, such as vehicles crossing over the opposing travel lane. This project will replace these features with end treatments that meet current design standards.

A draft environmental document has been completed, with final approval expected in September 2021.

# **Proposed traffic impacts**

Construction is scheduled for Summer 2028; however, construction could occur as early as Summer 2023 if funding becomes available.

During construction, WIS 81 will remain open to traffic. Work will be performed under temporary lane closures utilizing flagging for traffic control.

Access to residences and businesses along WIS 81 will be maintained throughout construction.

### **Real estate**

Real estate acquisitions are not anticipated for this project. All construction activities are expected to be completed within the existing right-of-way.
