# ADDENDUM NO. 02 1060-62-70 June 28, 2018

#### **Special Provisions**

## 19. Brining Building General Construction, Item SPV.0105.03.

## General Construction Specification Section 03300 – Cast-In-Place Concrete:

Replace 3.10.C. with the following:

C. Protective Coating: Apply protective surface treatment coating to the interior surfaces of concrete walls above slab elevation of the Brining Building according to standard spec. 502.3.13.2. Furnish a product from the department's approved products list for Concrete Protective Surface Treatment.

### General Construction Specification Section 03400 – Precast Concrete:

Add the following as paragraph 3.05.A.:

- 3.05 Protective Coating
- A. Apply protective surface treatment coating to the underside of the hollow core precast concrete roof plank of the Brining Building according to standard spec. 502.3.13.2. Furnish a product from the department's approved products list for Concrete Protective Surface Treatment.

#### General Construction Specification Section 04220 – Concrete Unit Masonry:

Add the following as paragraph 3.06.A.:

- 3.06 Protective Coating
- A. Apply protective surface treatment coating to the interior surfaces of concrete unit masonry walls of the Brining Building according to standard spec. 502.3.13.2. Furnish a product from the department's approved products list for Concrete Protective Surface Treatment that is compatible with concrete masonry units.

#### 23. Salt Storage Shed, Item SPV.0105.07.

## Part 3 – Design Criteria & Products:

Replace sub-paragraphs K.6.a, b, and c.. with the following:

- Asphalt Shingles Architectural asphalt shingles, carrying a manufacturer's warranty of at least 30 years for labor and materials. Roofing color to be selected by the engineer. Acceptable products are "Custom Sealdon" by CertainTeed, "Premium 30" by Georgia-Pacific, ""Super Seal" by Globe, "Aristocrat" by IKO, "Seal – Down 30" by Tamko, or equivalent.
- b. Roofing Underlayment Roofing underlayment to be No. 30 asphalt felt paper complying with ASTM D226.
- c. Sheathing APA rated, minimum 5/8-inch thick nominal, CDX plywood roof sheathing.
