ADDENDUM NO. 01 1580-04-74 December 20, 2022

Special Provisions

15. Removing Small Pipe Culverts, Item 203.0100.

Replace entire article language with the following:

Modify pertinent sections of standard spec 203 with the following:

The item of Removing Small Pipe Culverts shall include removal and disposal of asphalt and excavated material as incidental to the item of Removing Small Pipe Culverts. Excavated native soil material that is suitable for reuse shall only be stored and used outside the roadway shoulder points. Select borrow shall be used to backfill pipe excavations within the roadway shoulder points. The items of Asphaltic Surface, Base Aggregate Dense, Sawing Concrete, Select Borrow and Pavement Removal will be paid for by their respective items.

23. Ditch Cleaning, Item SPV.0090.02

Replace entire article with the following:

A Description

This special provision describes excavating, grading, shaping, compacting, topsoiling, and finishing all disturbed areas, and properly disposing of surplus material necessary to clean ditches, as shown on the plans and as directed by the engineer. All attempts shall be made to restore the original flowline determined through existing structures, prior plans or surveyed elevations.

B Materials

Incorporate materials in the work that are in accordance with the pertinent provisions of the standard specifications and special provisions.

C Construction

Perform all work in accordance with the pertinent provisions of the standard specifications.

Use all suitable materials removed from the ditches in other areas requiring fill material within the project limits as the engineer directs. Dispose of surplus and unsuitable material as specified in standard spec 205.3.12.

D Measurement

The department will measure Regrading Ditch in length by the linear foot, acceptably completed.

E Payment

The department will pay for measured quantities at the contract unit price under the following bid item:

Payment is full compensation for furnishing all excavation, grading, shaping, and compacting; furnishing and placing fill if necessary; disposal of surplus material.
