Special Provisions

3. Prosecution and Progress.

Replace bullet points under paragraph one under section titled Interim Completion and Liquidated Damages – Stage 2 – Side Road Right-in/Right-out: 7 Calendar Days with the following:

- All binder HMA is placed. Surface HMA at the option of the contractor.
- Median curb ramp improvements have taken place, where applicable.
- All signal loops are placed in the channelized left turn lane, where applicable.

Replace bullet points under paragraph one under section titled Interim Completion and Liquidated Damages – Stage 3 – Side Road Closure: 7 Calendar Days with the following:

- All binder HMA is placed. Surface HMA at the option of the contractor.
- All signal loops are placed at the side road, where applicable.
- Curb and gutter is placed.
- Curb ramp improvements have taken place, where applicable.

5. Traffic.

Replace paragraphs two and three under subsection titled <u>All Stages</u> under section titled **Traffic Operations** with the following:

Maintain at least one travel lane in each direction on all side roads at all times unless specifically mentioned within these special provisions.

STH 190 and side road right-turn and left-turn lanes are to remain open during peak hours unless specifically mentioned within these special provisions.

Add the following paragraph after paragraph three under subsection titled <u>All Stages</u> under section titled **Traffic Operations**:

Complete surface HMA during off-peak hours under flagging operations with minimal interruption to side road traffic. Alternately, fully close nonconsecutive side road intersections for surface HMA operations.

Add the following sub-bullet point under the bullet point titled <u>STH 190</u> under subsection titled <u>Stage 2 Traffic</u> under section titled **Traffic Operations**:

- <u>Stage 2 Off-Peak Milling and Paving</u>: Close left turn movements and center of intersections, while maintaining right turn movements, on nonconsecutive side roads for milling and paving operations.

Add the following sub-bullet point under the bullet point titled <u>STH 190</u> under subsection titled <u>Stage 3 Traffic</u> under section titled **Traffic Operations**:

Stage 3 Off-Peak Milling and Paving: Close nonconsecutive side road access for milling and paving operations.
