PROPOSAL REQUIREMENTS AND CONDITIONS

The bidder, signing and submitting this proposal, agrees and declares as a condition thereof, to be bound by the following conditions and requirements.

If the bidder has a corporate relationship with the proposal design engineering company, the bidder declares that it did not obtain any facts, data, or other information related to this proposal from the design engineering company that was not available to all bidders.

The bidder declares that they have carefully examined the site of, and the proposal, plans, specifications and contract forms for the work contemplated, and it is assumed that the bidder has investigated and is satisfied as to the conditions to be encountered, as to the character, quality, and quantities of work to be performed and materials to be furnished, and as to the requirements of the specifications, special provisions and contract. It is mutually agreed that submission of a proposal shall be considered conclusive evidence that the bidder has made such examination.

The bidder submits herewith a proposal guaranty in proper form and amount payable to the party as designated in the advertisement inviting proposals, to be retained by and become the property of the owner of the work in the event the undersigned shall fail to execute the contract and contract bond and return the same to the office of the engineer within fourteen (14) days after having been notified in writing to do so; otherwise to be returned.

The bidder declares that they understand that the estimate of quantities in the attached schedule is approximate only and that the attached quantities may be greater or less in accordance with the specifications.

The bidder agrees to perform the said work, for and in consideration of the payment of the amount becoming due on account of work performed, according to the unit prices bid in the following schedule, and to accept such amounts in full payment of said work.

The bidder declares that all of the said work will be performed at their own proper cost and expense, that they will furnish all necessary materials, labor, tools, machinery, apparatus, and other means of construction in the manner provided in the applicable specifications and the approved plans for the work together with all standard and special designs that may be designed on such plans, and the special provisions in the contract of which this proposal will become a part, if and when accepted. The bidder further agrees that the applicable specifications and all plans and working drawings are made a part hereof, as fully and completely as if attached hereto.

The bidder, if awarded the contract, agrees to begin the work not later than ten (10) days after the date of written notification from the engineer to do so, unless otherwise stipulated in the special provisions.

The bidder declares that if they are awarded the contract, they will execute the contract agreement and begin and complete the work within the time named herein, and they will file a good and sufficient surety bond for the amount of the contract for performance and also for the full amount of the contract for payment.

The bidder, if awarded the contract, shall pay all claims as required by Section 779.14, Statutes of Wisconsin, and shall be subject to and discharge all liabilities for injuries pursuant to Chapter 102 of the Statutes of Wisconsin, and all acts amendatory thereto. They shall further be responsible for any damages to property or injury to persons occurring through their own negligence or that of their employees or agents, incident to the performance of work under this contract, pursuant to the Standard Specifications for Road and Bridge Construction applicable to this contract.

In connection with the performance of work under this contract, the contractor agrees to comply with all applicable state and federal statutes relating to non-discrimination in employment. No otherwise qualified person shall be excluded from employment or otherwise be subject to discrimination in employment in any manner on the basis of age, race, religion, color, gender, national origin or ancestry, disability, arrest or conviction record (in keeping with s.111.32), sexual orientation, marital status, membership in the military reserve, honesty testing, genetic testing, and outside use of lawful products. This provision shall include, but not be limited to the following: employment, upgrading, demotion or transfer; recruitment or recruitment advertising; layoff or termination; rates of pay or other forms of compensation, and selection for training, including apprenticeship. The contractor further agrees to ensure equal opportunity in employment to all applicants and employees and to take affirmative action to attain a representative workforce.

The contractor agrees to post notices and posters setting forth the provisions of the nondiscrimination clause, in a conspicuous and easily accessible place, available for employees and applicants for employment.

STSP'S Revised June 29, 2023 SPECIAL PROVISIONS

1. General.

Perform the work under this construction contract for Project 1190-01-85, Northwest Region, USH 53 Bridge Deck Sealing, Bridge Deck Sealing (Various), USH 53, Douglas, Washburn, Barron, Chippewa, and Eau Claire Counties, Wisconsin as the plans show and execute the work as specified in the State of Wisconsin, Department of Transportation, Standard Specifications for Highway and Structure Construction, 2024 Edition, as published by the department, and these special provisions.

If all or a portion of the plans and special provisions are developed in the SI metric system and the schedule of prices is developed in the US standard measure system, the department will pay for the work as bid in the US standard system.

2. Scope of Work.

The work under this contract shall consist of application of an approved concrete sealer on concrete bridge deck surfaces and concrete bridge piers in the USH 53 corridor and all incidental items necessary to complete the work as shown on the plans and included in the proposal and contract.

104-005 (20090901)

3. Prosecution and Progress.

Begin work within 10 calendar days after the engineer issues a written notice to do so.

Provide the time frame for construction of the project within the 2024 construction season to the engineer in writing within a month after executing the contract but at least 14 calendar days before the preconstruction conference. Assure that the time frame is consistent with the contract completion time. Upon approval, the engineer will issue the notice to proceed within 10 calendar days before the beginning of the approved time frame.

To revise the time frame, submit a written request to the engineer at least two weeks before the beginning of the intended time frame. The engineer will approve or deny that request based on the conditions cited in the request and its effect on the department's scheduled resources.

All work shall be complete by July 31, 2024.

Environmental

Take any measures to ensure the deck sealing materials do not reach surface waters. Report any incidental spills to the 24-hour toll free hotline at 1 (800) 943-0003.

It is recommended that the contractor prepare a spill response contingency plan prior to beginning work.

If necessary, any incidental ground disturbances should be restored as soon as conditions permit. Appropriate erosion control devices should be in place until restoration of disturbed soils is complete.

Any material from this project inadvertently falling on to the bed and banks of the associated waterway and/or wetlands, must be removed immediately.

Northern Long-eared Bat

Northern Long-eared Bats (NLEB) have the potential to inhabit the project limits because they roost in trees and structures (bridges, culverts, buildings). Evaluation of the Federal Highway Administration's Range-Wide Biological Assessment and Programmatic Informal Consultation process, and/or consultation with the United States Fish and Wildlife Service (USFWS) has determined the project will have "no effect" on northern long-eared bats. If additional construction activities beyond what was originally specified are required to complete the work, such as additional tree clearing, approval from the WisDOT Regional Environmental Coordinator (REC) is required prior to initiating these activities.

The species and all active roosts are protected by the Federal Endangered Species Act. If an individual or active roost is encountered during construction or clearing operations, stop work and notify the engineer and the WisDOT REC.

4. Lane Rental Fee Assessment.

A General

The contract designates some lane closures to perform the work. No lane Rental Fee assessments will be charged for closing lanes during the off-peak freeway hours as shown in the contract. During peak freeway hours, if a lane is closed outside of the designated closures, the contractor will be subject to Lane Rental Fee assessments. If a lane is obstructed at any time due to contractor operations, it is considered a closure. The purpose of the lane rental is to enforce compliance of lane restrictions and discourage unnecessary closures.

The contractor will incur a Lane Rental Fee assessment for each lane closure during peak freeway hours. The contractor will not incur a Lane Rental Fee Assessment for closure of lanes during non-peak freeway hours. The peak freeway hours when lane closures are not allowed are stated in the Traffic article.

Submit the dates of the proposed lane, ramp, and roadway restrictions to the engineer as part of the progress schedule. Coordinate lane closures with any concurrent operations on adjacent roadways within 3 miles of the project.

If other projects are in the vicinity of this project coordinate lane closures to run concurrent with lane closures on adjacent projects when possible. When lane closures on adjacent projects extend into the limits of this project, Lane Rental Fee Assessments will only occur if the closure facilitates work under this contract.

B Lane Rental Fee Assessment

The Lane Rental Fee Assessment incurred for each lane closure of the roadway, per direction of travel, is as follows:

• \$500.00 per lane per 15 minutes.

The Lane Rental Fee Assessment represents the average cost of the interference and inconvenience to the road users for each closure. The Lane Rental Fee Assessment will be measured in 15-minute increments. All Lane Closure event increments less than 15 minutes will be assessed as a 15-minute increment.

Lane Rental Fee Assessments will be made based on the applicable rate for any and all closures whether work is being performed or not. The engineer, or designated representative, will be the sole authority in determining time period length for the Lane Rental Fee Assessment.

Lane Rental Fee Assessments will not be assessed for closures due to crashes, accidents or emergencies not initiated by the contractor.

The department will assess Lane Rental Fee Assessment Rate by the dollar under the administrative item Failing to Open Road to Traffic. The total dollar amount of Lane Rental Fee Assessment will be computed by multiplying the Lane Rental Assessment Rate by the number of 15-minute increments of each lane closure event as described above.

Lane Rental Fee Assessment will be in effect from the time of the Notice to Proceed until the department issues final acceptance.

5. Traffic.

A General

This special provision describes providing for USH 53 traffic during construction operations. USH 53 highway and structures shall be open to no less than one lane of traffic while performing work under this contract. The roadway within the lane closure shall be kept free of all equipment and materials, except during such time as actual deck preparation and coating application operations are in progress.

All signs including "Road Work Ahead" signs, "Left/Right Lane Closed" signs, "Road Work Next XX Miles" signs, "One Lane Road Ahead" Signs, "Speed Limit XX mph" advisory signs, "Lane Closed" signs, "End Road Work" Signs, "Ramp Closed Ahead" signs, "Ramp Closed" signs, all sign supports required, and all related traffic control items and materials shall be incidental to the item of Traffic Control, unless otherwise noted or provided in the plans.

B Temporary Lane Closures

Temporary lane closures are required for the deck sealing operations.

Project staging requires roadside work zone, construction vehicle and/or traffic control device encroachments within 6-foot horizontal and/or vertical, from the edge of the shoulder side of a lane. These encroachments require a temporary lane closure of the USH 53 lane closest to construction.

C Lane Closure Restrictions

Temporary lane closures are not allowed when no work is being performed. Maximum temporary lane closure length shall not exceed 3.5 miles.

The temporary lane closures shall be limited to the freeway non-peak hours (working hours), as defined in the following tables. During peak hours (non-working hours) and applicable Holiday Work Restrictions, the USH 53 traveled way and shoulders shall be entirely clear of equipment, barricades, signs, lights, or any other materials that may impede the free flow of USH 53 through traffic in each direction. Lane closures shall be limited to areas of actual construction operations. Minimize the actual time that lane closures are used.

D Shoulder Closures

Shoulder closures are not allowed when no work is being performed.

The contractor will be allowed to perform work on items that are located beyond 6-foot horizontal and/or vertical, from the edge of an open lane of traffic, utilizing a shoulder closure with the approval of the engineer. Construction vehicles and equipment shall be located outside of the 6-foot encroachment area. Shoulder closures shall only occur on one shoulder at a time. The existing roadway shall be open to through traffic in each direction. The lane closure restrictions outlined in this article shall not apply to work that can be completed with an approved shoulder closure. All shoulder closures shall be removed during applicable Holiday and Event Work Restrictions.

E Ramp Closures

All interchange ramps shall remain open to traffic at all times unless otherwise noted. The following ramps will require one off-peak closure to complete the structure protective surface treatment sealing operations. No signed detour shall be posted, and the maximum allowable ramp closure shall be limited to six hours between 10:00 PM and 4:00 AM any day of the week.

- USH 53 Northbound off-ramp to CTH V
 - Structure B-03-0196, Barron County
- USH 53 Northbound on-ramp from STH 29 WB
 - Structure B-09-0247, Chippewa County

The traffic control setup at exit and entrance ramp areas shall conform to the applicable standard detail drawings and WMUTCD requirements.

During the allowed ramp closures, the contractor shall have a superintendent or representative present. The superintendent or representative shall monitor the work activities to ensure that emergency vehicles are able to access the ramp. Do not re-open the ramp until all signs, barrels, barricades, and traffic control devices required to close the ramp are covered, moved, or removed.

F Advance Notification

Portable changeable message signs provided under this contract will be used for incident management except where shown in the plans and are to be operated by the Wisconsin State Patrol or Traffic Management Center (TMC). Place the required portable changeable message signs at the specified locations in the plan at least one week prior to construction.

G Wisconsin Lane Closure System Advanced Notification

Provide the engineer with a schedule of lane closures for the following week by noon on Thursday of the previous week. In addition, provide the following minimum advance notification to the engineer for incorporation into the Wisconsin Lane Closure System (LCS):

Discuss LCS completion dates and provide changes in the schedule to the engineer at weekly project meetings to manage closures nearing their completion date.

All lane and shoulder closures and duration are subject to the approval of the engineer based on operational needs and safety. Notify the engineer if there are any changes in the schedule, early completions, or cancellations of scheduled work.

Contact the State Patrol two weeks prior to the first lane closure. For incident management, contact Northwest Region State Highway Patrol.

H Work Restrictions

Conduct work operations in a manner that causes the least disruption to traffic movements on USH 53 and interchange ramps. Do not directly cross, unload materials from, stop in or otherwise interfere with traffic in any lane or ramp that is open to traffic with construction equipment or vehicles. All access to USH 53 by construction equipment will be at existing interchange locations.

Do not perform work in the median concurrently with work in the outside lane or outside shoulder with USH 53 traffic running between work areas.

Do not use maintenance crossings connecting northbound and southbound roadways of USH 53 during construction operations unless the median lanes are closed to traffic. The contractor is responsible for maintaining and restoring all maintenance crossings to their original condition upon completion of this contract.

Construction traffic shall not travel counter-directional adjacent to USH 53 through traffic, except for removal of traffic control devices for lane opening operations.

Equip all construction vehicles and equipment entering or leaving live traffic lanes with a hazard identification beam (flashing yellow signal). The beam shall be activated when merging into or exiting a live traffic lane.

Have available at all times, sufficient experienced personnel to promptly install, remove, and reinstall the required traffic control devices to route traffic to perform necessary construction operations according to the plans, these special provisions, and as directed by the engineer.

Do not park or store any equipment, vehicles, or construction materials within 30-feet of the edge of the traffic lane carrying USH 53 traffic or within the median during non-working hours. In the event of an emergency, protect any equipment, vehicles, or construction materials which remain within 30-feet of the edge of a traffic lane during non-working hours with temporary roadside barrier according to the standard specifications and meeting the requirements of the AASHTO Roadside Design Guide.

Conflicting existing signing shall be covered as directed by the engineer in the field.

The contractor shall not disturb, remove, or obliterate any traffic control signs, advisory signs, shoulder delineators or beam guard in place along the traveled roadways without the approval of the engineer.

Any signs damaged during construction operations shall be reinstalled or replaced at the contractors' expense.

Within 10 calendar days of receiving a progress payment for work completed by a subcontractor, pay the subcontractor for that work. The prime contractor may withhold payment to a subcontractor if, within 10 calendar days of receipt of that progress payment, the prime contractor provides written notification to the subcontractor and the department documenting "just cause" for withholding payment.

The prime contractor is not allowed to withhold retainage from payments due subcontractors.

Payment to Lower-Tier Subcontractors

Ensure that subcontracting agreements at all tiers provide prompt payment rights to lower-tier subcontractors that parallel those granted first-tier subcontractors in this provision.

Acceptance and Final Payment

Within 30 calendar days of receiving the semi-final estimate from the department, submit written certification that subcontractors at all tiers are paid in full for acceptably completed work.

Additional Special Provision 6 (ASP-6) Modifications to the standard specifications

Make the following revisions to the standard specifications:

108 Prosecution and Progress

Add subsection 108.9.4.1 effective with the November 2023 letting:

108.9.4.1 Winter Suspension for Completion Date Contracts

- (1) The contractor may request a winter suspension for a completion date contract. If the department determines weather conditions do not allow for the completion of the remaining work, the department may approve the contractor's request and determine the start date of the winter suspension. The end date of the winter suspension is March 31 or a date mutually agreed upon by both parties. For multi-year contracts, the department will only consider winter suspension for the final year of the contract.
- (2) During winter suspension, store all materials in a manner that does not obstruct vehicular and pedestrian traffic and protect the materials from damage. Install traffic control and other safety devices necessary to protect the traveling public and pedestrians. Provide suitable drainage and install temporary erosion control where necessary. If the winter suspension begins when liquidated damages are being assessed, or when the work has not progressed as scheduled and would not have been completed prior to the completion date, the cost of necessary pre-suspension work is incidental. If the winter suspension begins prior to the contract completion date, and the work has progressed as scheduled and would have been completed prior to the completion date, the cost of pre-suspension work will be paid as specified under 109.4.
- (3) For a winter suspension that begins prior to the contract completion date and the work has progressed as scheduled and would have been completed prior to the completion date, the engineer will extend contract time to correspond with the end of the winter suspension and liquidated damages will not be assessed during the winter suspension.
- (4) For a winter suspension that begins when liquidated damages are being assessed or when the work has not progressed as scheduled and would not have been completed prior to the completion date, the engineer will not extend contract time. Time will be suspended until the end of the winter suspension. Liquidated damages will not be assessed during the winter suspension and liquidated damages will resume at the end of the winter suspension.

108.10.2 Excusable, Non-Compensable Delays

108.10.2.1 General

Replace entire section with the following effective with the January 2024 letting:

- (1) Non-compensable delays, 108.10.2.1(3), are excusable delays not the contractor's or the department's fault. The engineer will not pay for the delay costs listed in 109.4.7 for non-compensable delays.
- (2) For non-compensable delays under calendar day and completion date contracts, the engineer will extend contract time if the conditions specified in 108.10.1 are met.  - 2. Extraordinary delays in material deliveries the contractor or their suppliers cannot foresee and forestall resulting from strikes, lockouts, freight embargoes, industry-wide shortages, governmental acts, or sudden disasters.
 - 3. Delays due to acts of the government, a political subdivision other than the department, or the public enemy.
 - 4. Delays from fires or epidemics.
 - Delays from strikes beyond the contractor's power to settle not caused by improper acts or omissions of the contractor, their subcontractors, or their suppliers.
 - 6. Altered quantities as specified in 109.3.

108.10.3 Excusable Compensable Delays

Replace entire section with the following effective with the January 2024 letting:

- (1) Compensable delays are excusable delays due to the department's actions or lack of actions. The engineer will grant a time extension for a compensable delay if the conditions specified in 108.10.1 are met.
- (2) The following are compensable delays:

- 1. A contract change for revised work as specified for extra work under 104.2.2.1, for a differing site condition under 104.2.2.2, or for significant changes in the character of the work under 104.2.2.4.
- 2. A contract change for an engineer-ordered suspension under 104.2.2.3.
- 3. The unexpected discovery of human remains, an archaeological find, or historical find consistent with 107.25.

Replace paragraph three with the following effective with the November 2023 letting:

(3) The department will perform testing conforming to the following standards:

Bulk specific gravity (G_{mb}) of the compacted mixture according to WTM T166.

Maximum specific gravity (Gmm) according to WTM T209.

Air voids (Va) by calculation according to WTM T269.

VMA by calculation according to WTM R35.

Asphalt content by ignition oven according to WTM T308, chemical extraction according to AASHTO T-164 method A or B, or automated extraction according to WTM D8159. If using an ignition oven to determine AC, conform to WTP H-003.

460.3.3.2 Pavement Density Determinations

Replace entire section with the following effective with the February 2024 letting:

- (1) The engineer will determine the target maximum density using department procedures described in WTM T355. The engineer will determine density according to CMM 815 and WTM T355 as soon as practicable after compaction and before placement of subsequent layers or before opening to traffic.

If a lane closure conflict is anticipated and an agreement cannot be made with the project 1190-08-79, 1198-10-77 and 1197-18-78 contractors, the engineer will determine the allowed lane closures for each project.
