Special Provisions

6. Utilities.

Replace entire section titled Laona Sanitary District No 1 (Sewer) with the following:

Laona Sanitary District No 1 (Sewer) has underground facilities located in the project area; however, no adjustments are anticipated. Please notify Laona Sanitary District No 1 (Sewer) at 715-674-7005, 14 days prior to beginning work at the following culvert pipes: 21008000213, 21008000214, 21008000215, 21008000216, 21008000217, 21008000218, and 21008000219 for observation.

Replace entire section titled Laona Sanitary District No 1 (Water) with the following:

Laona Sanitary District No 1 (Water) has underground facilities located in the project area; however, no adjustments are anticipated. Please notify Laona Sanitary District No 1 (Water) at 715-674-7005, 14 days prior to beginning work at the following culvert pipes: 21008000213, 21008000214, 21008000215, 21008000217, and 21008000219 for observation.

88. Notice to Contractor, Cofferdam STA 950+47 RT.

Culvert 21008000215 at STA 950+47 RT is being replaced and requires the use of cofferdams for construction. Laona Sanitary District No. 1 has underground sanitary and water utility lines running parallel to the southside of USH 8 roadway.

Due to the proximity of Laona Sanitary District No. 1 Sanitary and Water and restricted right of way, any underground materials that impact utilities in the area may not be used due to potential vibration damage and/or utility conflict. Please contact Laona Sanitary District at 715-674-7005 two weeks before beginning work in the area.

89. Notice to Contractor, Frontier Communications of WI LLC Kick-off Coordination Meeting.

Frontier Communication of WI LLC will provide temporary relocations to all their facilities to accommodate construction activities. Attend a mandatory coordination meeting with Frontier Communication of WI LLC at least one week before the preconstruction meeting to discuss these temporary relocations.
