

Other WisDOT Local Programs

Local Roads Improvement Program (LRIP) - Wis. Stats. s.86.31, Trans 206

- 2017-19 biennium \$66,066,000 SEG
- Provides state funding as a reimbursement for up to 50 percent of the cost of improvements to seriously deteriorating local roads.
- Projects are selected, let and administered by local governments with WisDOT review for eligibility and compliance.

<u>Transportation Alternatives Program (TAP)</u> - Wis. Stats. s.85.021, 23 USC 133(h)

- 2017-19 biennium \$14,098,600 FED
- Provides federal funding for up to 80 percent of the cost for multi-modal programs and projects defined as transportation alternatives. These projects are generally standalone bicycle and pedestrian projects.

Congestion Mitigation and Air Quality (CMAQ) - Wis. Stats. s.85.245, 23 USC 149

- 2017-19 biennium \$21,438,000 FED
- Provides federal funding for up to 80 percent of the cost for transportation-related projects that improve air quality and reduce congestion in air quality in non-attainment and maintenance areas (Door, Kenosha, Kewaunee, Manitowoc, Milwaukee, Ozaukee, Racine, Sheboygan, Walworth, Washington and Waukesha counties).

Connecting Highway Aids (CHA) - Wis. Stats. s.86.32

- 2017-19 biennium \$24,127,000 SEG
- Provides aid payments to municipalities for costs associated with maintenance of local roads designated as connecting highways, which connect segments of the state highway system.

Lift Bridge Aids (LBA) - Wis. Stats. s.86.32(2)(a)

- 2017-19 biennium \$5,318,400 SEG
- Reimburses the cities of Milwaukee, Racine, Green Bay and Manitowoc for costs associated with the operation and maintenance of 9 lift bridges on connecting highways within those communities.

Disaster Damage Aids (DDA) - Wis. Stats. s.86.34

- 2017-19 biennium \$2,000,000 SEG allocated, but sum-sufficient appropriation
- Provides for reimbursement of up to 75 percent of the cost to repair highways damaged in a qualifying disaster event

County Forest Road Aids (CFRA) - Wis. Stats. s.86.315

- 2017-19 biennium \$569,400 SEG
- Provides aid payments to counties to defray the cost associated with improvement and maintenance of public roads in county forests.

Expressway Policing Aids (EPA) - Wis. Stats. s.59.84(10)(b)

- 2017-19 biennium \$2.047.800 SEG
- Provides aid payments to the Milwaukee County Sheriff's Department for the costs of patrolling expressways within Milwaukee County.
