### **Delinquent taxes = Suspended license**

WisDOT will suspend licensed Wisconsin dealers, as well as individual licensees (sales, BID, buyer) if the Wisconsin Department of Revenue verifies there are delinquent taxes owed to the State of Wisconsin. The suspension will remain on any business and/or individual until those taxes are paid.



If those taxes are not paid within a timely manner, a warning letter from WisDOT will be mailed to dealership owners, and/or individual licensees. The letter will provide 30 days to pay the delinquent tax liability or their license(s) will be suspended.

If the taxes are not paid within 30 days, the licensees will receive a letter from WisDOT notifying them their license is suspended on the effective date in the letter. If an individual licensee (sales, BID, buyer) is being suspended, that individual cannot buy or sell cars and must return their credentials to the DMV's Dealer Licensing Unit. If a dealership license is suspended, no vehicles may be bought or sold and a DMV investigator will retrieve any licenses, credentials, and license plates to hold until the suspension is removed.

This joint initiative between the Department of Revenue and the Department of Transportation began in July 2017.

## New Agent Training Videos Are Here!

As noted in the last issue of *Plain Dealing*, the Dealer and Agent Section has created a new series of training videos for eMV Agent and eMV11 processing systems. These short video tutorials, designed with simplicity and convenience in mind, will cover a wide range of topics and functions available on both of these processing systems.

### Watch for flood damaged vehicles hitting the market



History is sure to repeat itself and vehicles from the recent hurricanes will find their way to Wisconsin.

It may be difficult for consumers to identify whether floods have damaged a vehicle. The effects of such damage can be serious and may not be apparent until many months after the damage occurred. Wisconsin brands titles with a permanent brand "flood damage."

Those vehicles that make it to Wisconsin without being branded may still cause your dealership disclosure issues. All vehicles being offered for sale must be inspected, and the Wisconsin Buyers Guide must be completed following Trans 139.02(15) (a) and (b) "Reasonable care:"

(a) For vehicle inspections, a standard that requires an interior and exterior inspection, an under-hood and under-vehicle inspection, and a test drive. It does not require taking the vehicle apart or running tests unless it is necessary to diagnose apparent symptoms. Brakes may require some disassembly to satisfy the requirements in <u>Chapter Trans 305</u>.

(b) For records inspections, a standard that requires providing information the dealership gets from manufacturer and auction notices: prior owner documents and disclosures, and their own vehicle inspection and repair records. It does not require contacting prior owners, or obtaining records of previous titles unless necessary to clarify inconsistent or questionable information that is apparent.

To assist consumers in identifying vehicles with possible flood damage, direct consumers to the <u>National Insurance Crime Bureau (NICB) website</u>. It offers an opportunity to check vehicle identification

#### DMV issues driver license/ID cards compliant with federal standards

# When can salespeople start selling after passing salesperson exam?

Newly-licensed salespeople do not need to wait until the dealership receives their salesperson license in the mail before beginning to sell vehicles. Salespeople are legal to sell as long as they have the receipt showing they took the salesperson exam.

Applicants' motor vehicle salesperson license number (required to be recorded, in part, on the motor vehicle purchase contract of vehicles they sell) is the same as their Wisconsin Driver License number. Salespeople awaiting their license card after passing the test may show the first eight digits of their Driver License number on purchase contracts they write.

## Finance personnel must also be licensed

Did you know: Finance and insurance (F&I) personnel are required to be licensed as a motor vehicle salesperson?

Some people believe F&I employees aren't really *selling* the car so they don't need a salesperson license. This belief is incorrect and could be a problem for the dealer.

The definition of a motor vehicle salesperson in Wisconsin State Statute §218.0101(24) includes "....or other person who is employed by a motor vehicle dealer for the purpose of selling or *approving* retail sales...." Furthermore, Wisconsin Trans Code 138.02(10) defines selling as "....to transfer or offer to transfer ownership of a motor vehicle for compensation...."

## RV Dealers can now charge a service fee

The recent budget bill includes a provision that allows recreational vehicle dealers to assess an additional service fee for completing any salesrelated vehicle inspections or forms. Like motor vehicle dealers, this fee must be reasonable and

WisDOT is currently finalizing the last set of updates for the new MV11 - Title and License Plate Application form.

You will be notified as soon as the new version is available.

Vendors and the dealers must continue to use the current version of the MV11 (May 2015) to ensure the application is processed correctly.

### Be recognized for emissions repairs

#### Benefits to becoming a recognized repair facility with the Wisconsin Vehicle Inspection Program (WIVIP)

Motorists in southeastern Wisconsin seek emissions related repairs when their vehicles cannot pass an emissions inspection, which is a biennial requirement for most vehicles to complete registration renewal or at the time a vehicle changes ownership.

A repair business achieves recognition if it has at least one technician with advanced emissions related training (see details below) and has completed the registration process with the Wisconsin Vehicle Inspection Program (WIVIP).



Repair facilities that meet the "recognition" criteria can realize the following advantages:

- \* Increased business
- \* Free advertising
- \* Increased credibility
- \* Repair work eligible for waiver consideration.
- \* Free training opportunities

While the motorist has a choice of where to take a vehicle for repairs, only emissions related repairs that are performed at a recognized repair facility and are related to the vehicle's failed emissions inspection diagnostic trouble codes (DTC) may be used to meet the cost waiver criteria. The cost waiver enables the motorist to complete the registration renewal for the vehicle or fulfill the change of ownership test requirement.

#### How to Get Recognized

If your dealership employs at least one technician with ASEL1 certification, WISETECH certification, or is a new car dealership, it is one step away from becoming a recognized repair facility.

You may register your dealership, free of charge, with the Wisconsin Vehicle Inspection Program (WIVIP) by completing the <u>registration application</u>. website. Other DMV sites with .org and .com are not official and may have extra charges for forms or list information that is outdated or incorrect.

Another benefit of registering your dealership with the program is that you will be notified by email of future training opportunities.

If you would like to become recognized, but need to be certified, or re-certify, you can find information regarding the ASE process on the <u>ASE website</u>.

## As a reminder: Emissions repair cost limit for waiver was increased to \$879 as of July 1

The repair cost limit for all model year vehicles subject to emissions testing increased from \$872 to \$879, *effective July 1, 2017*. This figure is adjusted annually by the DNR per NR 485.045.



Vehicles subject to emissions testing that continue to fail may be eligible for a cost waiver if actual costs of emissions related repairs exceed the repair cost limit. **Only repairs that are related to the vehicle's cause of failure can be used to apply for a cost waiver.** Costs covered by any warranty or costs to repair/replace emission control equipment that has been removed, modified or disconnected are excluded.

The owner must have emissions related repairs performed on the vehicle at a recognized repair facility to qualify for waiver consideration. Here is a list of recognized repair facilities.

The application form to apply for Recognized Repair Shop status may also be found at the above link. TRANS 131.02(39) includes franchised NEW car dealerships as recognized repair facilities.

#### APU/DLU

The Agent Partnership Unit (APU) answers phone calls from dealers, government agencies, financial institutions, gas stations, grocery stores and various other types of agents throughout the state. These agents electronically process either title and registration, or renewal registration applications on behalf of the DMV.

The Dealer Licensing Unit (DLU) issues and renews multiple business license types. Individual licenses are issued to individuals who are selling or purchasing vehicles on behalf of dealerships. DLU answers dealer licensing questions as well as providing information about consumer harm and how to file a dealer complaint to the general public.
